SUPPLEMENTAL ORDER

San Diego Economy Line, Inc. requests that the Commission extend the suspension of its authority to provide service on Route No. 1 because of continuing financial difficulties. The carrier states it is not able to perform any transportation service to the general public over this route. Previously, the Commission granted a suspension from May 18, 1971 until April 1, 1972 by Decision No. 78684, from April 2, 1972 until April 1, 1973 by Decision No. 79861 from April 2, 1973 until April 1, 1974 by Decision No. 81252. The present request under consideration would be to reaffirm and continue this authority in suspension.

San Diego Transit Corporation has written a letter to the Commission stating that it has a contract with the County of San Diego to inaugurate service over a portion of Route 1, starting in January 1976.

In the circumstances there appears to be no objection to extending the suspension of authority to San Diego Economy Line, Inc. to operate over the entire Route 1, until December 31, 1975. This order will so provide.

IT IS ORDERED that:

1. The suspension of authority heretofore granted to San Diego Economy Line, Inc. for providing passenger service on its Route 1 is extended to December 31, 1975.

2. Should San Diego Economy Line, Inc. seek any further extension of authority to suspend passenger service on Route 1, it shall file a formal application that states its justification for another continuance, and further states whether it will, in fact, provide such service at an early date.

In all other respects, Decision No. 78684 dated May 18, 1971 shall remain in full force and effect.


