ORDER GRANTING MOTION FOR DISMISSAL OF PETITIONS AND VACATING ORDERS SETTING HEARING

At the October 7, 1975 further adjourned hearing in these matters the California Trucking Association moved for dismissal of certain of its petitions which concern the definition of the terms "origin", "destination", and "carrier's equipment" as presently employed in the Commission's several minimum rate tariffs. If petitioner's motion is granted, the staff suggests that the Commission's related orders setting hearing be vacated.

It has been shown that good cause exists for the granting of petitioner's motion for dismissal and that the Commission's related orders setting hearing should be vacated concurrently therewith.
