ORDER OF REVOCATION

By Decision No. 75953 dated July 22, 1969, in Application No. 50844, Edward Vanderdoes, George Ishibashi, and George Koga, doing business as International Limousine Service Company, were granted a Certificate of Public Convenience and Necessity (PSC-850) to operate as a Passenger Stage Corporation between certain points in the City of Gardena and certain service areas located in Los Angeles County.

By recent letter, George N. Koga informed this Commission that International Limousine Service Company was no longer conducting the subject operations and asked that the Certificate of Public Convenience and Necessity to operate as a Passenger Stage Corporation be revoked.

It appears and the Commission finds that these matters constitute good cause for the revocation of the aforementioned certificate and that such revocation would not be adverse to the public interest. The Commission, therefore, concludes that the certificate should be revoked and that tariffs and timetables applicable to the service thereunder should be canceled.





