BEFORE THE PUBLIC UTILITIES COMMISSION OF THE STATE OF CALIFORNIA

Application of THOMPSON BROS., INC., a California corporation, and THE SANTA FE TRAIL TRANSPORTATION COMPANY, a Kansas corporation, to transfer the certificate of public convenience and necessity of Thompson to Santa Fe, and for interim relief for Santa Fe to temporarily operate Thompson authority.

ORIGIN

FINAL OPINION

By Decision No. 82940 dated June 5, 1974, the Commission granted interim authority to Thompson Bros., Inc. to lease its operating authority as a highway common carrier to The Santa Fe Trail. Transportation Company, a Kansas corporation, pending a final order of the Interstate Commerce Commission authorizing the parties to transfer said operating authority pursuant to an agreement of sale.

The certificate was granted by Decision No. 79860 dated March 28, 1972 in Application No. 52032 and authorizes the transportation of general commodities, with certain exceptions, between various points within the State. The sale, which also includes the transfer of corresponding interstate authority, is subject to the exclusive jurisdiction of the Interstate Commerce Commission pursuant to Section 5 of the Interstate Commerce Commission.

On October 22, 1975, the Interstate Commerce Commission issued an order authorizing the sale and transfer as requested.

FINAL ORDER

IT IS ORDERED that:

1. In compliance with the final order of the Interstate Commerce Commission and on or before July 1, 1976 Thompson Bros., Inc. may sell and transfer the operating rights referred to in the application to The Santa Fe Trail Transportation Company.

2. Within thirty days after the transfer the purchaser shall file with the Commission written acceptance of the certificate and a true copy of the bill of sale or other instrument of transfer.

3. Purchaser shall amend or reissue the tariffs on file with the Commission, naming rates and rules governing the common carrier operations transferred to show that it has adopted or established, as its own, the rates and rules. The tariff filings shall be made effective not earlier than one day after the effective date of this order on not less than one day's notice to the Commission and the public, and the effective date of the tariff filings shall be concurrent with the transfer. The tariff filings made pursuant to this order shall comply in all respects with the regulations governing the construction and filing of tariffs set forth in the Commission's General Order No. 80-Series. Failure to comply with the provisions of General Order No. 80-Series may result in a cancellation of the operating authority granted by this decision.

4. On or before the end of the third month after the transfer, the purchaser shall cause to be filed with the Commission, in such form as the Commission may prescribe, an annual report, or reports, related to the operations of the seller for the period commencing with the first day of the current year to and including the effective date of the transfer.

5. In the event the transfer authorized in paragraph 1 is completed, effective concurrently with the effective date of the tariff filings required by paragraph 3, a certificate of public convenience and necessity is granted to The Santa Fe Trail Transportation Company, a corporation, authorizing it to operate as a highway common carrier, as defined in Section 213 of the Public Utilities Code, between the points set forth in Appendix A of this decision. To the extent that such authority duplicates any authority heretofore granted by this Commission to The Santa Fe Trail Transportation Company, such prior authority is revoked.

6. The certificate of public convenience and necessity granted by Decision No. 79860 is revoked effective concurrently with the effective date of the tariff filings required by paragraph 3.

7. Purchaser shall comply with the safety rules administered by the California Highway Patrol and the insurance requirements of the Commission's General Order No. 100-Series.

8. Purchaser shall maintain its accounting records on a calendar year basis in conformance with the applicable Uniform System of Accounts or Chart of Accounts as prescribed or adopted by this Commission and shall file with the Commission on or before March 31 of each year, an annual report of its operations in such form, content, and number of copies as the Commission, from time to time, shall prescribe.

9. Purchaser shall comply with the requirements of the Commission's General Order No. 84-Series for the transportation of collect on delivery shipments. If purchaser elects not to transport collect on delivery shipments, it shall make the appropriate tariff filings as required by the General Order.

Santa Fe Trail Transportation Company, a Kansas corporation, by the certificate of public convenience and necessity granted in the decision noted in the margin, is authorized to conduct operations as a highway common carrier as defined in Section 213 of the Public Utilities Code for the transportation of general commodities as follows:

> Between the following points, serving all intermediate points on the said routes and off-routes points within 15 miles thereof; subject to the restriction that no shipment will be transported having both origin and destination south of the northern boundary of San Luis Obispo, Kern and San Bernardino Counties except where such shipment is a part of a split pickup or delivery shipment, one or more components of which, has origin or destination north of said line, except as specified below:

- 1. Red Bluff and the junction of State Highway 99 and State Highway 4 near Stockton via State Highway 99.
- 2. Redding and Wheeler Ridge via Interstate Highway 5.
- 3. Williams and Grass Valley via State Highway 20.
- 4. Grass Valley and Placerville via State Highway 49.
- 5. Junction of State Highway 99 and State Highway 70 south of Paradise and State Highway 99 and State Highway 70 south of Trowbridge via State Highway 70.

Used household goods, personal effects and 1. office, store and institution furniture, fixtures and equipment not packed in salesmen's hand sample cases, suitcases, overnight or boston bags, brief cases, hat boxes, valises, traveling bags, trunks, lift vans, barrels, boxes, cartons, crates, cases, baskets, pails, kits, tubs, drums, bags (jute, cotton, burlap or gunny) or bundles (completely wrapped in jute, cotton, burlap, gunny, fibreboard, or straw matting).

- 2. Automobiles, trucks and buses, viz.: new and used, finished or unfinished passenger automobiles (including jeeps), ambulances, hearses and taxis; freight automobiles, automobile chassis, trucks, truck chassis, truck trailers, trucks and trailers combined, buses and bus chassis.
- 3. Livestock, viz.: barrows, boars, bulls, butcher hogs, calves, cattle, cows, dairy cattle, ewes, feeder pigs, gilts, goats, heifers, hogs, kids, lambs, oxen, pigs, rams (bucks), sheep, sheep camp outfits, sows, steers, stags, swine or wethers.
- 4_ Liquids, compressed gases, commodities in semiplastic form and commodities in suspension in liquids in bulk, in tank trucks. tank trailers, tank semitrailers or a combination of such highway vehicles.
- 5. Commodities when transported in bulk in dump-type trucks or trailers or in hopper-type trucks or trailers.
- 6. Commodities when transported in motor vehicles equipped for mechanical mixing in transit.
- 7. Portland or similar cements, in bulk or packages, when loaded substantially to capacity of motor vehicle.
- 8. Logs.
- 9. Articles of extraordinary value.
- Cleaning, scouring and washing compounds, 10. textile softeners, laundry bleach, vegetable oil shortening, cooking oil, peanut butter, and prepared edible flour when transported in pool shipments in truckloads of over 20,000 pounds from Sacramento to retail stores.
- Salt, when transported between Newark and Sacramento. 11.
- 12. Sugar when transported between Tracy and Sacramento, or from Crockett to points within 350 miles of Crockett.

- 13. Trisodium Phosphate when transported from Richmond to Sacramento in shipments of 40,000 pounds or more.

Commodities, the transportation of which, because of their size or weight, requires the use of special equipment; or commodities, the transportation of which, because of their size or weight, require special permits from State, County or City governmental agencies to transport said commodities over the public highways.

The San Diego Territory includes that area embraced by following an imaginary line starting at a point approximately four miles north of La Jolla on the Pacific Coast shoreline running east to Miramar on U.S. Highway 395; thence following an imaginary line running southeasterly to Lakeside on State Highway 67; thence southerly on County Road S 17 (San Diego County) and its prolongation to State Highway 94; easterly on State Highway 94 to Jamul; thence due south following an imaginary line to the California-Mexico Boundary Line; thence westerly along the boundary line to the Pacific Ocean and north along the shoreline to point of beginning.
