## ORDER OF REVOCATION

By Decision No. 80803 dated December 12, 1972, in Application No. 53475, Earl C. Neeley and Beryl Neeley, doing business as Kern River Valley Bus Lines, was granted a Certificate of Public Convenience and Necessity (PSC-920) to transport passengers, baggage, and express between Lake Isabella and Bodfish; and between Lake Isabella and Kernville and certain territories intermediate and adjacent thereto.

Since March 27, 1973, Earl C. Neeley and Beryl Neeley, dba Kern River Valley Bus Lines, have had no evidence on file with this Commission showing adequate protection against liability imposed by law for payment of damage for personal injury or property damage as required by General Order No. 101-C.

Earl C. Neeley and Beryl Neeley, doing business as Kern River Valley Bus Lines, through their attorney, William R. Hulsey, informed this Commission by letter dated July 5, 1974 of their desire to abandon the operation. He advised that the carrier had never commenced service pursuant to the authorization of Decision No. 80803.

The carrier had previously requested and was granted an extension of time until August 17, 1974 by Decision No. 83408 in Application No. 53475 to exercise its Certificate of Public Convenience and Necessity.

It appears and the Commission finds that these matters constitute good cause for revocation of the aforenamed certificate and that such revocation would not be adverse to the public interest. The Commission, therefore, concludes that the certificate should be revoked and that tariffs and timetables applicable to the service thereunder should be canceled.

IT IS ORDERED that the Certificate of Public Convenience and Necessity to operate as a Passenger Stage Corporation to transport passengers, baggage, and express between Lake Isabella and Bodfish; and between Lake Isabella and Bella Vista; and between Lake Isabella and Kernville and certain territories intermediate and adjacent thereto, authorized by Decision No. 80803 in Application No. 53475 is hereby revoked and all effective tariffs and timetables on file with the Commission in the name of Earl C. Neeley and Beryl Neeley, doing business as Kern River Valley Bus Lines, are canceled upon the effective date of this order.
