OPINION AND ORDER

By Decision No. 85039 dated October 21, 1975, in Application No. 55973, Flour Transport, Inc., was authorized to transport dry sugar in bulk for General Foods Corp., The Pillsbury Company and Sam Andy Foods at rates less than the established minimum rates from plant sites at or near Carlton and Betteravia to the City of Commerce and Placentia.

By Application No. 56047, as amended, applicant seeks to modify the aforementioned authority by: (1) including DCA Food Industries, Inc., as a consignee at the City of Industry and Holly Sugar Co. as a shipper; (2) establishing the same less-than-minimum rates from Carlton and Betteravia to the City of Industry as now apply to Placentia; and (3) providing for the assessment of an additional rate of 10 cents per 100 pounds for Sunday service.

The application is based on special circumstances and conditions detailed therein.

Revenue and expense data submitted by applicant in Application No. 55973 indicate that the transportation involved may reasonably be expected to be profitable under the proposed rates.

The certificate of service indicates that a copy of Application No. 56047 was mailed to California Trucking Association on

November 3, 1975. Said application and the amendment thereto were listed on the Commission's Daily Calendar of November 5 and 17, 1975. No objection to the granting of the application, as amended, has been received.

In the circumstances, the Commission finds that applicant's proposal is reasonable. A public hearing is not necessary. The Commission concludes that the application, as amended, should be granted.


IT IS ORDERED that:


1. Decision No. 85039 is hereby amended by substituting for Appendix A thereof Appendix B which is attached hereto and by this reference made a part hereof.


2. The authority granted herein shall expire with October 21, 1976, unless sooner cancelled, modified or extended by order of the Commission.



Flour Transport, Inc. is authorized to transport dry sugar, in bulk, for DCA Food Industries, Inc., General Foods Corp., The Pillsbury Company and Sam Andy Foods from and to the following locations at the rates indicated:

Flour Transport, Inc. is also authorized to transport dry sugar, in bulk, for Holly Sugar Co. from and to the following locations at the rates indicated:

3.	Plant site of Holly Sugar Co., at or near Carlton	City of Commerce City of Industry Placentia	67 64 64

The above rates are subject to the following conditions:

- A. The minimum weight per shipment shall be 50,000 pounds.
- B. Rates include pneumatic unloading service when consignee provides electrical power at no cost to carrier.
- C. For deliveries made between 12 midnight Saturday and 12 midnight Sunday, add to the above rates 10¢ per 100 pounds.
- D. In all other respects the rates and rules set forth in Minimum Rate Tariff 2 shall apply.
