ORDER OF MODIFICATION

By Decision No. 85309 dated January 6, 1976, Public Distribution Corporation was granted an in lieu certificate which provided for an extension of service. Through inadvertence the authorized extension did not fully correspond with the amended proposal as set forth in late-filed Exhibit 17, which specifically restricted service to applicant's warehouse in the city of Vernon, on the one hand, and all points and places within the Los Angeles Basin Territory, on the other hand.
