Because of certain irregularities in restating the new certificate, Decision No. 85253 will again be amended by substituting a new Appendix A.

> Except that pursuant to the authority herein granted carrier shall not transport any shipments of:

- 1. Used household goods, personal effects and office, store and institution furniture, fixtures and equipment not packed in salesmen's hand sample cases, suitcases, overnight or boston bags, brief cases, hat boxes, valises, traveling bags, trunks, lift vans, barrels, boxes, cartons, crates, cases, baskets, pails, kits, tubs, drums, bags (jute, cotton, burlap or gunny) or bundles (completely wrapped in jute, cotton, burlap, gunny, fibreboard, or straw matting).
- 2. Automobiles, trucks and buses, viz.: new and used, finished or unfinished passenger automobiles (including jeeps), ambulances, hearses and taxis; freight automobiles, automobile chassis, trucks, truck chassis, truck trailers, trucks and trailers combined, buses and bus chassis.
- 3. Livestock, viz.: barrows, boars, bulls, butcher hogs, calves, cattle, cows, dairy cattle, ewes, feeder pigs, gilts, goats, heifers, hogs, kids, lambs, oxen, pigs, rams (bucks), sheep, sheep camp outfits, sows, steers, stags, swine or wethers.
- 4 Liquids, compressed gases, commodities in semi-plastic form and commodities in suspension in liquids in bulk, in tank trucks, tank trailers, tank semitrailers or a combination of such highway vehicles.
- 5. Commodities when transported in bulk in dump-type trucks or trailers or in hopper-type trucks or trailers.
- 6. Commodities when transported in motor vehicles equipped for mechanical mixing in transit.

- 7. Portland or similar cements, in bulk or packages, when loaded substantially to capacity of motor vehicle.
- 8. Logs.
- 9. Articles of extraordinary value.
- 10. Cleaning, scouring and washing compounds, textile softeners, laundry bleach, vegetable oil shortening, cooking oil, peanut butter, and prepared edible flour when transported in pool shipments in truckloads of over 20,000 pounds from Sacramento to retail stores.
- 11. Salt, when transported between Newark and Sacramento.
- 12. Sugar when transported between Tracy and Sacramento, or from Crockett to points within 350 miles of Crockett.
- 13. Trisodium Phosphate when transported from Richmond to Sacramento in shipments of 40,000 pounds or more.
- 14. Empty containers of not less than sixty cubic feet capacity each when transported for returning loads of articles or commodities in paragraphs 11, 12 or 13 above.
- 15. Commodities, the transportation of which, because of their size or weight, requires the use of special equipment; or commodities, the transportation of which, because of their size or weight, requires special permits from State, County or City governmental agencies to transport said commodities over the public highways.
