ORDER AMENDING ORDER OF SUSPENSION AND INVESTIGATION

On June 25, 1974 the Commission issued an Order of Suspension and Investigation in Case No. 9757 suspending, to and including October 28, 1974 the effective date of tariff sheets filed under General Telephone Company of California (General) Advice Letter No. 3157. By Decision No. 83623 the period of suspension was extended to and including April 28, 1975.

On April 14, 1975 General filed a Supplement to Advice Letter No. 3157 requesting its permanent suspension and concurrently filed a substitute for it under Advice Letter No. 3341 to permit continuation of the investigation beyond the normal statutory limit. By Decision No. 84408 the Commission ordered that the operation and effectiveness of the tariff sheets filed by Advice Letter No. 3341 be suspended to and including September 11, 1975. On August 19, 1975 the Commission by Decision No. 84801 extended the period of suspension to and including March 11, 1976.

On February 25, 1976 General filed a Supplement to Advice Letter No. 3341 requesting its permanent suspension and concurrently filed a substitute for it under Advice Letter No. 3713 to permit continuation of the investigation beyond the normal statutory limit.

The Commission finds that the suspension and investigation should be continued beyond March 11, 1976; therefore,

IT IS ORDERED that:

1. The operation and effectiveness of the tariff sheets providing for the expansion of personal signaling service to include the Redlands Exchange and the San Bernardino Exchange, filed by Advice Letter No. 3713, are hereby suspended to and including July 24, 1976 unless otherwise ordered.

2. The original Order of Investigation under Case No. 9757, filed June 25, 1974, shall remain in effect as to matters considered under Advice Letter No. 3713 to the same extent as under Advice Letters Nos. 3157 and 3341.

3. Tariff sheets filed under Advice Letter No. 3341 of General Telephone Company of California are hereby permanently suspended.

The Executive Director of the Commission is directed to cause a certified copy of this order to be served forthwith upon General Telephone Company of California and to mail a copy to each of the other parties of record.
