ORDER OF REVOCATION

By Decision 72814 dated July 25, 1967, in Application 49206, Ronan Erickson, Jeannie Erickson and John A. Kazy, doing business as Barbary Coast Tours, were granted a Certificate of Public Convenience and Necessity (PSC-807) to operate as a passenger stage corporation between points in a service area in San Mateo County, on the one hand, and points of interest in the City and County of San Francisco and Marin County, on the other hand.

Since October 14, 1970, Barbary Coast Tours has had no evidence on file with the Commission showing adequate protection against liability imposed by law for payment of damage for personal injury or property damage, as required by General Order 101-C.

The Carrier discontinued service on or about October 14, 1970.

It appears and the Commission finds that these matters constitute good cause for the revocation of the aforementioned certificate and that such revocation would not be adverse to the public interest. The Commission, therefore, concludes that the certificate should be revoked and that tariffs and timetables applicable to the service thereunder should be canceled.

IT IS ORDERED that the Certificate of Public Convenience and Necessity to operate as a passenger stage corporation between points in a service area in San Mateo County, on the one hand, and points of interest in San Francisco City and County and Marin

County, on the other hand, authorized by Decision 72814 in Application 49206 is hereby revoked and all effective tariffs and timetables on file with the Commission in the name of Ronan Erickson, Jeannie Erickson and John A. Kazy, doing business as Barbary Coast Tours, are canceled upon the effective date of this order.

The Executive Director of the Commission shall mail a certified copy of this order to Ronan Erickson at 1490 Cavedale Road, Sonoma, CA 95476, Jeannie Erickson at 1490 Cavedale Road, Sonoma, CA 95476 and John A. Kazy at 523 Barcelona Drive, Millbrae, CA 94030, last known addresses as shown on the Commission's records.

The effective date of this order shall be twenty days after the date hereof, unless before such effective date there shall have been filed with the Commission written response to this order requesting public hearing in which event the effective date of this order shall be stayed until further order of the Commission.
