ORDER OF REVOCATION By Decision 78525 dated April 2, 1971, in Application 52503, Berkeley Charter Lines, Inc. was granted a Certificate of Public Convenience and Necessity to operate as a passenger stage corporation (PSC-364) between Tiburon Ferry Terminal on the one hand, and Tiburon-Belvedere Peninsula and Mill Valley on the other hand and intermediate points. Since November 5, 1972, Derkeley Charter Lines, Inc. has had no evidence on file with this Commission showing adequate protection against liability imposed by law for payment of damage for personal injury or property damage, as required by General Order 101-C. On or about December 31, 1972, Berkeley Charter Lines, Inc. abandoned service and ceased operations. It appears and the Commission finds that these matters constitute good cause for the revocation of the aforenamed certificate and that such revocation would not be adverse to the public interest. The Commission, therefore, concludes that the certificate should be revoked and that tariffs and timetables applicable to the service thereunder should be canceled. IT IS ORDERED that the Certificate of Public Convenience and Necessity to operate as a passenger stage corporation between Tiburon Ferry Terminal on the one hand, and Tiburon-Belvedere Peninsula and Mill Valley on the other hand, authorized by Decision 78525 in Application 52503 is hereby revoked and all effective tariffs and - 1 -
