By this application, Trans-Aero Systems Corporation, a corporation, requests authority to deviate from the provisions of Minimum Rate Tariff 2 in connection with the transportation of

clothes hampers, willowware and storage hassocks for Joy of California from San Jose to points in the San Francisco and Los Angeles areas. 1

The application is based on special circumstances and conditions detailed therein.

The application was listed on the Commission's Daily Calendar of November 24, 1975. California Trucking Association objected to the ex parte handling of this matter stating that there are no known cost savings directly attributable to the involved transportation and only a specious cost development enables the allegation of profitable operations. However, the original and supplemental revenue and expense data submitted by applicant are sufficient to determine that the transportation involved may reasonably be expected to be profitable under the proposed rates.

In the circumstances, the Commission finds that applicant's proposal is reasonable. A public hearing is not necessary. The Commission concludes that the application should be granted as set forth in the ensuing order.
