ORDER DENYING REHEARING

A petition for rehearing of Decisions Nos. 85584, 85585, 85586, and 85587 was filed by California Trucking Association on March 16, 1976. In accordance with Section 1733 of the Public Utilities Code, the Commission suspended the effectiveness of Decisions Nos. 85584, 85585, 85586 and 85587 by the issuance of Decisions Nos. 85694 and 85695 on April 13, 1976.

The Commission having considered each and every allegation of the petition, and being of the opinion that good cause for rehearing has not been made to appear;

IT IS ORDERED that

1. Rehearing of Decisions Nos. 85584, 85585, 85586 and 85587 is hereby denied.

2. Minimum Rate Tariff 2 (Appendix D of Decision No. 31606, as amended) is further amended by incorporating therein, to become effective May 15, 1976, Sixty-fourth Revised Page 14, and Second Revised Page 14-A, which pages are attached hereto and by this reference made a part hereof.

3. Minimum Rate Tariff 1-B (Appendix B of Decision No. 65834, as amended) is further amended by incorporating therein, to become effective May 15, 1976, Seventeenth Revised Page 14, which page is attached hereto and by this reference made a part hereof.

4. Minimum Rate Tariff 9-B (Appendix A of Decision No. 67766, as amended) is further amended by incorporating therein, to become effective May 15, 1976, Seventeenth Revised Page 17, which page is attached hereto and by this reference made a part hereof.

5. Minimum Rate Tariff 19 (Appendix A of Decision No. 41363, as amended) is further amended by incorporating therein, to become effective May 15, 1976, Sixteenth Revised Page 15-A, which page is attached hereto and by this reference made a part hereof.

6. Common carriers subject to the Public Utilities Act, to the extent that they are subject to Decisions Nos. 31606, 65834, 67766 and 41363, as amended, are hereby authorized to establish in their tariffs the revisions necessary to conform with the further adjustments ordered herein.

7. Tariff publications authorized to be made by common carriers as a result of the order herein may be made effective on not less than ten days notice to the Commission and to the public if filed not later than sixty days after the effective date of the minimum rate tariff pages incorporated in this order.

8. Common carriers, in establishing and maintaining the amendments authorized hereinabove, are hereby authorized to depart from the provisions of Section 461.5 of the Public Utilities Code to the extent necessary to adjust long- and short-haul departures now maintained under outstanding authorizations; such outstanding authorizations are hereby modified only to the extent necessary to comply with this order; and schedules containing the amendments published under this authority shall make reference to the prior orders authorizing long- and short-haul departures and to this order.


