SUPPLEMENTAL OPINION

By Decision No. 84946 dated September 30, 1975, applicant Sereno Del Mar Water Company was authorized to extend service to the Gleason Beach Assessment District upon a showing, satisfactory to the staff, that it has developed, installed, and connected for operation water production facilities and storage which will meet the service standards and requirements of General Order No. 103 (G.O. 103), including fire protection.

Applicant has submitted data pursuant to Decision No. 84946. A staff memorandum dated April 27, 1976 outlines the staff evaluation of applicant's data and recommends that:

- Applicant install a pressure reducing value at the upper end of Calle Del Sol main and a pressure reducing value at the lower end of Los Santos Drive.
- 2. Applicant install a minimum of 40,000 gallons of additional storage to meet the minimum fire flow requirements of G.O. 103.
- 3. The Commission authorized the utility to deviate from its filed tariffs and accept the facilities as a contribution-in-aidof-construction.

The staff memorandum will be received in evidence as Exhibit No. 4.

Findings

1. Pressure reducing values installed at the upper end of Calle Del Sol main and the lower end of Los Santos Drive main will assure adequate pressure control and adequate supplies to all users.

2. A minimum of 40,000 gallons of additional storage is required to meet the minimum fire flow requirements of G.O. 103.

3. Applicant should be authorized to deviate from its filed tariff and accept the new facilities as a contribution-in-aid-of-construction.

Conclusion

When the facilities described in Findings 1 and 2 are completed applicant may extend service to the Gleason Beach Assessment District.

SUPPLEMENTAL ORDER

IT IS ORDERED that:

1. Sereno Del Mar Water Company is authorized to extend service to the Gleason Beach Assessment District after it has installed the pressure reducing valves specified in Finding 1 and the storage facilities specified in Finding 2.

2. Sereno Del Mar Water Company is authorized to deviate from its filed tariff and accept the facilities authorized to be installed herein as contributions-in-aid-of-construction.

3. The authority granted by Ordering Paragraphs 1 and 2 is subject to the express condition that if the water facilities in the Gleason Beach Assessment District to be conveyed to Sereno Del Mar Company, or subsequently to any regulated public utility successor of Sereno Del Mar Water Company, are ever acquired by any public entity by purchase or by eminent domain, the proceeds from the disposition of such facilities shall be held in trust by the utility or any utility successor for the benefit of the owners of the land assessed, and shall be disposed of only as may be directed by this Commission or by a Court in the exercise of its jurisdiction

ever the acquisition of such facilities by such public entity. This condition shall be void sixty years after the dates upon which Sereno Del Mar Water Company shall have originally acquired the water facilities in the Gleason Beach Assessment District.

4. After the effective date of this order and after completing the construction required by this order applicant is authorized to file revised tariff sheets, including tariff service area maps, to provide for the application of its present tariff schedules to the areas certificated by this order. Such filing shall comply with General Order No. 96-A. The effective date of the revised tariff sheets shall be five days after the date of filing.

5. This authority shall expire if not exercised within one year unless extended or modified by order of the Commission.

The effective date of this order shall be twenty days after the date hereof.
