SUPPLEMENTAL OPINION AND ORDER

Decision 85108 dated November 12, 1975, in this proceeding authorized General Produce Transport, Inc., a corporation, to assess a less-than-minimum rate for the transportation of frozen fruits and vegetables between Watsonville and Castroville for five shippers.

By Petition for Modification of Decision 85108, General Produce Transport, Inc., seeks to amend said decision to include Richard A. Shaw, Inc., and Valley Frost Company as additional shippers.

The petition is based on special circumstances and conditions detailed therein.

The petition was listed on the Commission's Daily Calendar of June 18, 1976. No objection to the granting of the petition has been received.

In the circumstances, the Commission finds that petitioner's proposal is reasonable. A public hearing is not necessary. The Commission concludes that the petition should be granted and the effective date of this order should be the date hereof because there is an immediate need for this rate relief.

IT IS ORDERED that:

1. Decision 85108 is hereby amended by substituting for Appendix A thereof Amended Appendix A which is attached hereto and by this reference made a part hereof.

2. The authority granted herein shall expire with November 12, 1976, unless sooner cancelled, modified or extended by order of the Commission.
