OPINION AND ORDER

By this application, Airborne Freight Corporation, a corporation, seeks to amend its tariff by providing for the establishment of pickup and delivery service at Alviso, Dublin, Niles and Westlake Village and the cancellation of the following pickup and delivery points: Centerville, Fairfield, Pillar Point AFB, Sebastopol and Suisun.¹

Applicant alleges that the pickup and delivery points it proposes to add to and cancel from its California intrastate tariff are and are not respectively set forth in its interstate tariff and it desires to make the two tariffs uniform in connection with services it performs in California. Applicant avers that it is not receiving freight for transportation from or to the pickup and delivery points which are proposed to be cancelled. The cancellation of such pickup and delivery points would result in minimal technical increases.

Applicant states that increases resulting from the proposal herein would not increase its California intrastate gross revenue by as much as one percent.

The application was listed on the Commission's Daily Calendar of January 30, 1976. No objection to the granting of the application has been received.

In the circumstances, the Commission finds that applicant's proposal is reasonable and justified. A public hearing is not necessary. The Commission concludes that the application should be granted.


IT IS ORDERED that:

1. Airborne Freight Corporation, a corporation, is authorized to amend its Official Airfreight Forwarder California Intrastate Rate Tariff Cal.P.U.C. 1 by adding and cancelling pickup and delivery points as specifically proposed in the application.
2. Tariff publications authorized to be made as a result of the order herein shall be filed not earlier than the effective date of this order and may be made effective not earlier than the fifth day after the effective date of this order on not less than five days' notice to the Commission and to the public.
3. The authority herein granted shall expire unless exercised within ninety days after the effective date of this order.
