SECOND INTERIM OPINION AND ORDER

By Decision 85862, dated May 25, 1976, in the above proceeding, R. Cali & Bros., a corporation, was authorized to deviate from the provisions of Minimum Rate Tariff 2 in connection with the transportation of fibreboard boxes, knocked down flat, for Container Corporation of America between Santa Clara and points in Fresno County.

G. A. Wesson, Traffic Supervisor, Western Traffic Division, Container Corporation of America (CCA), on behalf of R. Cali & Bros., informed the Commission by letter that the production facility of CCA at San Jose was inadvertently omitted from the amended application in this proceeding. He stated that such facility is intermediate to Fresno from Santa Clara and the application of the rate from San Jose to Fresno should be clarified.

In the circumstances, the Commission finds that the necessary modification should be made by the order herein. A public hearing is not necessary. The Commission concludes that Decision 85862 should be amended accordingly and the effective date of this order should be the date hereof as corrective action should be taken as soon as possible.

IT IS ORDERED that:


1. Decision 85862 is hereby amended by substituting for Appendix A thereof Amended Appendix A which is attached hereto and by this reference made a part hereof.


2. Decision 85862, as herein amended, shall expire with June 1, 1977.

AMENDED APPENDIX A
(Supersedes Appendix A of Decision 85862)

R. Call & Bros., a corporation, is authorized to transport Fibreboard Boxes, other than corrugated, knocked down flat for Container Corporation of America between San Jose and Santa Clara, on the one hand, and points in Fresno County, on the other hand, at a rate of 59 cents per 100 pounds, subject to a minimum weight of 30,000 pounds.

Conditions:

1. Applicant has not indicated that subhaulers will be engaged nor have any costs of subhaulers been submitted. Therefore, if subhaulers are employed, they shall be paid no less than the rate authorized herein.
2. In all other respects, the rates and rules in Minimum Rate Tariff 2 shall apply.
