ORDER OF REVOCATION

Ora B. Smith and Chester R. Smith, doing business as Santa Cruz Transit Company (PSC 25), were granted a Certificate of Public Convenience and Necessity to conduct operations as a passenger stage corporation by Decision 62133 dated June 13, 1961 in Application 32349, as amended by Decision 69137 dated May 25, 1965 in Application 46971, by Decision 71312 dated September 20, 1966 in Application 48773, by Decision 73883 dated March 19, 1968 in Application 49982, and by Decision 80110 dated May 31, 1972 in Application 43459.

By letter dated June 15, 1976 Russell E. Baker, General Manager of Santa Cruz Transit Company, advised the Commission that the Certificate of Public Convenience and Necessity to operate as a passenger stage corporation is no longer in use and requested that the certificate be revoked. He also informed the Commission that on January 1, 1975, the Santa Cruz Transit Company was incorporated and the Charter-party Carrier Certificate, TCP-52A, which is still being used, has been transferred to Santa Cruz Transit Garage Co., Inc., dba Santa Cruz Transit Company. This transfer has previously been authorized by the Commission.

It appears and the Commission finds that these matters constitute good cause for the revocation of the aforenamed

certificate and that such revocation would not be adverse to the public interest. The Commission, therefore, concludes that the certificate should be revoked and that tariffs and timetables applicable to the service thereunder should be cancelled.

IT IS ORDERED that the Certificate of Public Convenience and Necessity to operate as a passenger stage corporation, authorized by Decision 62133 in Application 32349, as amended by Decision 69137 in Application 46971, by Decision 71312 in Application 48773, by Decision 73883 in Application 49982 and by Decision 80110 in Application 43459, is hereby revoked and all effective tariffs and timetables on file with the Commission in the name of Ora B. Smith and Chester R. Smith, doing business as Santa Cruz Transit Company, are cancelled upon the effective date of this order.

The Executive Director of the Commission shall mail a certified copy of this order to Ora B. Smith and Chester R. Smith, Santa Cruz Transit Company, 912 Pacific Avenue, Santa Cruz, CA 95060, last known address as shown on the Commission's records.
