SUPPLEMENTAL ORDER

By Decision No. 85553, dated March 9, 1976, in this proceeding, California Cities Water Company was authorized to increase rates for its San Dimas District to be further increased by supplemental order if applicant completed certain installations to improve water quality.

By letter dated September 3, 1976, applicant has informed the Commission that the required improvements have been made. The staff-verified effects of the improvements on revenue requirement are as follows:
