## OPINION

Keyava Construction Co. requests a dump truck carrier permit to operate in the Counties of Sacramento, Placer, Sutter, Solano, Yuba, Sierra, Amador, Glenn, Yolo, Colusa, El Dorado, Nevada, Butte, San Joaquin, and Tehama. Notice of the filing of the application appeared in the Daily Transportation Calendar of November 1, 1983. No protests have been filed.

## Discussion

Applicant, a California corporation, holds no authority from this Commission. Its balance sheet as of August 30, 1983 shows no cash on hand and the amount of \$168,000 owed to a bank. This is offset by receivables of \$710,000 and "other deposits" of \$10,000. Its total assets are \$900,000. Its equity accounts total \$351,000. The application is supported by a prime carrier who has indicated that he expects to use applicant to haul 10,000 tons in the first year.

## Findings of Fact

- 1. Applicant:
  - a. Is a fit and proper corporation to receive a permit to operate as a dump truck carrier.
  - b. Has sufficient operating knowledge and financial ability to initiate and continue the proposed operation.
  - c. Has demonstrated that the privilege sought:
    - (1) Will not endanger the safety of the public or interfere with the public use of the public highways or impair the condition or maintenance of them, directly or indirectly.

- (2) Will not unnecessarily burden the public highways.
- (3) Is necessary to serve the public and will not impair the ability of presently permitted dump truck carriers to provide adequate service at the lowest possible reasonable rates.
- 2. Applicant has resided in the State of California for at least the 90 days preceding the filing of this application.
- 3. It can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment.
- 4. The following order complies with the Commission's Energy Efficiency Plan.
- 5. A public hearing is not necessary. Conclusions of Law
- 1. Applicant should be granted a dump truck carrier permit authorizing operations within and between points in the Counties of Sacramento, Placer, Sutter, Solano, Yuba, Sierra, Amador, Glenn, Yolo, Colusa, El Dorado, Nevada, Butte, San Joaquin and Tehama.
- 2. The following order should be effective today to be consistent with other permit grants.

## ORDER

IT IS ORDERED that the Executive Director shall issue a dump truck carrier permit to Keyava Construction Co., a California corporation, authorizing operations within and between points in the Counties of Sacramento, Placer, Sutter, Solano, Yuba, Sierra, Amador, Glenn, Yolo, Colusa, El Dorado, Nevada, Butte, San Joaquin, and Tehama upon compliance with General Order Series 100.

This order is effective today.
