# OPINION

Walter A. Felizianetti, doing business as Walter's Charter Service, seeks a certificate of public convenience and necessity to operate as a Class B charter-party carrier of passengers from his home terminal at 444 Whispering Pines Drive, Space 100, Scotts Valley.

Applicant states that he owns a 1957 G.M.C. 41-passenger coach and has had driving and service experience with Greyhound Lines, Inc. and with tour bus companies. A satisfactory financial statement is included in the application, and it is stated that numerous groups from schools, churches, senior centers, and service clubs have contacted applicant to provide them with charter-party transportation in the Scotts Valley area.

Notice of the filing of the application appeared in the Commission's Daily Transportation Calendar on January 4, 1984. No protests have been received.

### Findings of Fact

- 1. Applicant has the ability, experience, equipment, and financial resources to perform the proposed service.
- 2. Public convenience and necessity require the service proposed by applicant.
- 3. Applicant should be authorized to pick up passengers within a radius of 40 air miles from his home terminal at 444 Whispering Pines Drive, Scotts Valley.

4. It can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment.

### Conclusion of Law.

Public convenience and necessity have been demonstrated and a certificate should be granted.

# ORDER

#### IT IS ORDERED that:

- 1. A certificate of public convenience and necessity, to be renewed each year, is granted to Walter A. Felizianetti authorizing him to operate as a Class B charter-party carrier of passengers, as defined in Public Utilities Code § 5383, from a service area with a radius of 40 air miles from applicant's home terminal at 444 Whispering Pines Drive, Scotts Valley.
  - 2. Applicant shall:
    - a. Obtain California Highway Patrol (CHP) clearance for each vehicle to be used in this Class B charter-party operation.
    - b. Notify the Commission and CHP of any addition or deletion of vehicle(s) used in the service prior to use.
    - c. Establish the authorized service within 360 days after this order is effective.
- 3. The Passenger Operations Branch will issue the annual renewable certificate on Form PE-695 as authorized by Resolution PE-303 when it receives CHP clearances and evidence of liability protection in compliance with General Order Series 115.
- 4. In providing service under the certificate, applicant shall comply with General Orders Series 98 and 115 and the CHP safety rules.
- 5. This certificate does not authorize the holder to conduct any operations on the property of or into any airport unless such operation is authorized by both this Commission and the airport authority involved.

6. The Class B certificate of public convenience and necessity granted by this order does not authorize round-trip sightseeing-tour service, which is not subject to regulation by this Commission. It does, however, permit applicant to offer charter service to a sightseeing-tour operator.

This order becomes effective 30 days from today.
