It has come to the attention of the Commission that a clerical error exists in Ordering Paragraph 14 on page 7 of Decision (D:) 84-04-104 in the above-captioned proceeding.

Under Resolution A-4661,


IT IS ORDERED that Ordering Paragraph 14 of D.84-04-104 be amended to provide as follows:

14. New Ordering Paragraph 4 is added to read:

"The 1984 test year revenue requirement adopted in Phase 2 of the PT&T rate case will be reduced by the product of (1) the reduction in 1983 test year revenue requirement resulting from Ordering Paragraph 3, multiplied by (2) the ratio of the number of days in 1984 during which the Phase 1 rates are in effect to the total number of days in the test year."
