Decision (D.) 93672 dated November 3, 1981 authorized Temescal Water Company to raise the rates charged for water service. The increase was granted on a temporary, or interim basis, to provide an interval for the Commission's Hydraulic Branch staff to consider the effect of the Economic Recovery Tax Act of 1981 (ERTA) on revenue requirement.

The staff recently completed a study and determined that application of the ERTA of 1981 would reduce the revenue less than 1% and the quantity block rates less than one mil. The staff recommended that the final decision adopt the rates authorized in the Interim Order of November 3, 1981.

Findings of Fact

- 1. Interim D.93672 authorized Temescal Water Company to increase rates charged for water service.
- 2. The decision was interim, to be effective for an indefinite period, so the Commission staff would have time to consider the effect of applying the ERTA of 1981 to revenue requirement.
- 3. After completion of a study, the staff advised that application of the ERTA would have little effect on revenue or rates and recommended that the Commission's final order adopt the rates set by the interim order.

Conclusion of Law

The interim order issued on November 3, 1981 should be adopted as the final order in this proceeding.
