<u>O P I N I O N</u>

Applicants have applied for authority to transfer a day shift home-to-work route from David Munoz (PSC-910) to Homer W. Price (PSC-1138). The proposed transfer involves a route between Dublin and the United Airlines Maintenance Base at San Francisco Airport. David Munoz was granted the route in Decision 85057 in Case 9725. Both applicants have agreed that the sole payment arising from the transfer will be that Homer W. Price will pay transfer fees.

In addition to the requested route transfer, Homer W. Price requests authority to restructure his present authority (granted in Decision 92285, dated October 8, 1980 in Application 59808) to absorb the proposed transferred route and meet his passengers' current needs.

The applicants state the transfer and route restructure is necessary for a viable service because of reduced ridership from the Dublin and Castro Valley/Hayward Area.

Notice of the filing of this application appeared on the Daily Transportation Calendar on December 12, 1983. There were no protests.

Findings of Fact

1. Homer W. Price has the ability, experience, equipment, and financial resources to perform the proposed service.

2. The transfer will not be adverse to the public interest.

3. A public hearing is not be necessary.

4. The authority held by David Munoz will be revoked on the date the new tariffs become effective and a new certificate issued to Homer W. Price.

5. This order should be effective on the date signed to facilitate the continuation of these needed passenger stage services without interruption.

Conclusion of Law

The proposed transfer is in the public interest and should be authorized. A public hearing is not necessary.

Only the amount paid to the State for operative rights may be used in rate fixing. The State may grant any number of rights and may cancel or modify the monopoly feature of these rights at any time.

ORDER

IT IS ORDERED that:

1. David Mumoz may transfer the operative rights specified in the application to Homer W. Price.

- 2. Transferee shall:
 - a. File with the Transportation Division written acceptance of the certificate and a copy of the transfer document within 30 days after transfer.
 - b. Amend or reissue sellers' tariffs and timetables, state in them when the service will start, make them effective 10 or more days after this order is effective, and allow at least 10 days' notice to the Commission.
 - c. Comply with General Orders Series 79, 98, 101, and 104, and the California Highway Patrol safety rules.

- d. File an annual report of sellers' operations of the route being transferred for the period from the first day of the current year to the date of transfer.
- e. Maintain accounting records in conformity with the Uniform System of Accounts.

3. If the transfer is completed, on the effective date of the tariffs a certificate of public convenience and necessity is granted to Homer W. Price, an individual, authorizing him to operate as a passenger stage corporation, as defined in PU Code Section 226, between the points and over the routes set forth in First Revised Title Pages 1 and 2 of Appendix PSC-1138, to transport passengers and baggage.

4. The certificate of public convenience and necessity granted by D.85057 for service between Dublin and United Airlines Maintenance Base at San Francisco Airport is revoked on the effective date of the tariffs.

5. This certificate does not authorize the holder to conduct any operations on the property of or into any airport unless such operation is authorized by the airport involved.

SECTION 1. GENERAL AUTHORIZATIONS, RESTRICTIONS, LIMITATIONS, AND SPECIFICATIONS.
