<u>O P I N I O N</u>

By this application, Colorite Corporation, doing business as S & J Trucking and Leasing Company (S & J), requests authority to cancel its participation in tariffs issued by Cal-West Tariff Bureau, Inc. (CWTB) and to publish an individual tariff. S & J will publish rates at the levels it is authorized to charge in tariffs of CWTB.

S & J believes it would be better served, for various reasons, by publishing an individual tariff. S & J alleges that due to inherent differences in the tariffs, certain technical increases and reductions would result. Applicant states that the proposal, if granted, would not increase its California intrastate gross revenue by as much as one percent.

The proposal is not a major action significantly affecting energy efficiency within the meaning of Public Utilities (PU) Code Sections 3502.1 and 3502.2.

The application was listed on the Commission's Daily Transportation Calendar of March 22, 1984. No objection to the granting of the application has been received.

Findings of Fact

1. The increases resulting from this proposal are technical in nature and are justified.

2. The proposal will result in increasing applicant's California intrastate gross revenue by less than one percent.

3. The following order has no reasonably foreseeable impact on the energy efficiency of highway carriers.

4. Authority to depart from the provisions of PU Code Section 461.5 is justified.

5. A public hearing is not necessary.

Conclusion of Law

The application should be granted.

<u>O R D E R</u>

IT IS ORDERED that:

1. Colorite Corporation, doing business as S & J Trucking and Leasing Company, is authorized to cancel its participation in tariffs issued by Cal-West Tariff Bureau, Inc., and to concurrently publish an individual tariff as discussed in this opinion.

4. The cancellation of applicant's participation in Cal-West Tariff Bureau, Inc., tariffs shall be concurrent with the effective date of its individual tariff.
