ORDER EXTENDING TIME

By Decision (D.) 84-01-058, dated January 19, 1984, in Application 83-11-62, Kenneth L. Houck (applicant) (PSC-1325), doing business as Marin County Charters, was granted authority to operate as a passenger stage corporation to provide home-to-work passenger service between Bel Marin Keys, Marin County and Downtown San Francisco.

Since D.84-01-058 was signed, applicant has learned that financing and vehicle acquisition will require more time than originally anticipated. Therefore, by request of April 30, 1984 applicant asks that his authority be extended through June 30, 1985.

Findings of Fact

1. The requested authority originally granted to Kenneth L. Houck in D.84-01-058 will expire on January 19, 1985.
2. An additional six months is needed by applicant to complete arrangements for vehicle acquisition and financing.
3. Public convenience and necessity require the proposed service.

Conclusion of Law

The request should be granted. A public hearing is not necessary.

IT IS ORDERED that:

1. Applicant's passenger stage authority (PSC-1325) shall be extended six months to be effective through June 30, 1985.
2. Appendix PSC-1325 is amended to reflect the above extension of time by incorporating First Revised Page 1, cancelling Original Page 1.



SECTION 1. GENERAL AUTHORIZATIONS, RESTRICTIONS, LIMITATIONS,
AND SPECIFICATIONS.

Kenneth L. Houck, by the certificate of public convenience and necessity granted by the decision noted in the margin, is authorized as a passenger stage corporation to transport home-to-work passengers between points in Bell Marin Keys (Marin County), on the one hand, and San Francisco, on the other hand, subject, however, to the authority of this Commission to change or modify this authority at any time and subject to the following provisions:

- a. All transportation of passengers shall originate at and shall be destined to the service points specified in Section 2.
- b. When route descriptions are given in one direction, they apply to operation in either direction unless otherwise indicated.
- *c. This authority shall, unless modified or extended by further order of the Commission, expire on June 30, 1985.
