## ORDER MODIFYING DECISION (D.) 84-03-109 AND DENYING REHEARING THEREOF

An application for rehearing of D.84-03-109 has been filed by Lorrie's Travel and Tours, Inc. (Lorrie). We have carefully considered each and every allegation of error therein and are of the opinion that good cause for granting rehearing has not been shown. However, D.84-03-109 should be modified to reflect the fact that, by Resolution PE-491, dated April 18, 1984, SFO Airporter was permitted to suspend scheduled service between downtown San Francisco and the Oakland International Airport (OAK). In view of that change it would be consistent with our other actions in D.84-03-109 to grant Lorrie's request for authority to provide such service. The following order does so.

We also wish to make it clear that Lorrie may assess lower fares for scheduled service than for on-call service in the same area so long as provisions of Ordering Paragraph 3 of D.84-03-109 are not violated. No further issues need be discussed. Therefore, good cause appearing,

IT IS ORDERED that

1. D.84-03-109 is modified as follows:

(a) Ordering Paragraph 2 on page 20, slip, shall read,

"2. The passenger stage corporation certificate of Lorrie's Travel and Tours, Inc. (PSC-1003) is amended as set forth in the revised pages attached to this order as Appendix B, to:

- (a) Provide scheduled service from Territory One to Oakland International Airport;
- (b) Provide scheduled services from only Territories Two and Three to San Francisco International Airport; and
- (c) Authorize permanent on-call service in Territory Three."

(b) Ordering Paragraph 8 on page 22, slip, shall read,

"The portion of A.83-04-48 of Lorrie's Travel and Tours, Inc., requesting the option of scheduled service from Territory One to San Francisco International Airport is denied without prejudice, however, other portions, as addressed above, are granted."

(c) Conclusion of Law 1 on page 20, slip, shall read,

"1. PU Code §1032 is directly applicable in these proceedings only between Lorrie, on the one hand, and SFO Airporter and Sharabi, on the other, with respect to Lorrie's request for downtown scheduled service to San Francisco International Airport."

(d) Finding of Fact 4 on page 19, slip, shall read,

"4. There is no scheduled service from Lorrie's Territory One (downtown San Francisco) to the Oakland International Airport nor to the San Francisco International Airport from parts of San Francisco outside of Territory One; the availability of such service to these territories would extend travel option and convenience to the public."

(e) Finding of Fact 6 on page 19, slip, shall read,

"6. Lorrie has the ability to conduct its proposed on-call service in Territory Three, to provide scheduled service outside of its Territory One to the San Francisco International Airport and to provide scheduled service from Territory One to the Oakland International Airport."

- (f) Page 2 of Appendix B, shall read as attached hereto.
- (g) The time limits provided in Ordering Paragraphs 5a, 5b and 5c shall begin today with respect to the amended authority set forth in Section 1g of Appendix B.



  - h. When route descriptions are given in one direction, they apply to operation in either direction unless otherwise indicated.
