In the Matter of the Application of Jerry G. Cromwell doing business as Jerry Cromwell Equipment for authority to obtain a Dump Truck Carrier Permit to operate in the counties of San Diego, Orange, Riverside, and Imperial.

Application 84-04-152 (Filed April 30, 1984)

OPINION

Jerry G. Cromwell, doing business as Jerry Cromwell Equipment, has applied for a dump truck carrier permit to authorize operation in the Counties of San Diego, Orange, Riverside, and Imperial. Applicant's terminal is located in Lakeside, San Diego County, California. Notice of the filing of the application appeared in the Daily Transportation Calendar of June 25, 1984. No protests have been filed.

Applicant recently obtained authority from this Commission, as a highway contract carrier (File T-144,530). Applicant will transport sand, rock, and gravel using one end dump power unit and one pull trailer. He will not be engaging subhaulers and will not lease equipment from employees.

Applicant has resided in the State of California continuously for not less than 90 days preceding the filing of this application.

Certificates supporting the application were filed by Bud's Trucking, Dave Martin Supplies, and Minnesota Asphalt, Inc. All three stated that they will use applicant's service.

Applicant's balance sheet dated April 24, 1984 lists assets of \$101,000, liabilities of \$6,400, and a net worth of \$94,600.

Findings of Fact

- 1. Applicant:
 - a. Is a fit and proper person to receive a permit to operate as a dump truck carrier.
 - b. Has sufficient operating knowledge and financial ability to initiate and continue the proposed operation.
 - c. Has demonstrated that the privilege sought:
 - (1) Will not endanger the safety of the public or interfere with the public use of the public highways or impair the condition or maintenance of them, directly or indirectly.
 - (2) Will not unnecessarily burden the public highways.
 - (3) Is necessary to serve the public and will not impair the ability of presently permitted dump truck carriers to provide adequate service at the lowest possible reasonable rates.
- 2. Applicant has resided continuously in California for at least 90 days preceding the filing of the application.
- 3. It can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment.
- 4. The following order complies with the Commission's Energy Efficiency Plan.
- 5. A public hearing is not necessary.

Conclusions of Law

- 1. Applicant should be granted a dump truck carrier permit authorizing operations within and between points in the Counties of San Diego, Orange, Riverside, and Imperial.
- 2. The following order should be effective today to be consistent with the grant of other permits.

ORDER

IT IS ORDERED that the Executive Director shall issue a dump truck carrier permit to Jerry G. Cromwell, an individual doing business as Jerry Cromwell Equipment, authorizing operations within and between points in the Counties of San Diego, Orange, Riverside, and Imperial upon compliance with General Order Series 100.

This order is effective today.
