## <u>O P I N I O N</u>

Robert M. Wash and Joyce A. Wash (transferees) seek Commission authority under Public Utilities (PU) Code §§ 854 and 3551 to acquire control of Owl Transfer Co. (Owl) from J. C. Jones, Joanne E. Jones, and Elmer H. Tuschhoff (transferors) through the transfer of all outstanding capital stock.

Owl is a California corporation. A copy of its articles is on file with the Commission in File T-42056. It holds authority as a highway common carrier for the transportation of general commodities, as a highway contract carrier, and as a household goods carrier.

Documents attached to the application show that transferees are purchasing 30 of Owl's 304 outstanding shares, and the remaining 274 shares are being purchased and redeemed by Owl. Transferees agree to pay S30,717 by way of a promissory note for the shares they acquire and also agree to guarantee Owl's promissory note in the amount of S280,548 arising from the purchase and redemption agreement between transferors and Owl. Transferees' financial statement dated March 22, 1983 shows net worth of S74,055.

Robert M. Wash is currently the president and general manager of Owl. He has been employed for 12 years by the corporation in its operations and is alleged to be thoroughly familiar with the company and qualified to operate it in an efficient and competent manner.

The transfer of control for which approval is sought occurred on June 30, 1983. Commission authority was not obtained at that time because the parties were unaware of the requirements of PU Code §§ 854 and 3551.

Notice of the filing of the application appeared on the Commission's Daily Transportation Calendar of June 6, 1984. No protests have been received.

#### Findings of Fact

1. The proposed transfer of control is not adverse to the public interest.

2. Transferees have the financial resources and experience to successfully provide the certificated services.

3. A public hearing is not required.

4. In order that there be no disruption in the conduct of Owl's business, this order should be effective immediately. <u>Conclusions of Law</u>

1. The application should be granted as set forth in the following order.

2. The action taken shall not be construed as a finding of value of the capital stock of Owl.

### ORDER

IT IS ORDERED that:

1. Robert M. Wash and Joyce A. Wash may control Owl Transfer Co. under the terms and conditions set forth in the application.
