ORDER MODIFYING DECISION 84-07-150

On July 18, 1984 the Commission issued Decision (D.) 84-07-150 authorizing a general rate increase for Pacific Power & Light Company (PP&L). It has come to our attention that certain of the Baseline allowances adopted in the decision were determined in a manner inconsistent with the procedures used in determining the allowances for the Pacific Gas and Electric Company's (PG&E) and San Diego Gas & Electric Company's (SDG&E) territories.

The Baseline allowances in question here apply only to master-metered multi-family residential service (Schedule No. DM-9). In both the PG&E (D.83-12-068, December 22, 1983) and SDG&E (D.83-12-065, December 20, 1983) decisions we adopted a uniform set of Baseline allowances for all residential schedules. This is consistent with our interpretation of the Baseline legislation and Section 739 of the Public Utilities Code.

In the PP&L decision we adopted Baseline quantities for Schedule No. DM-9 (Appendix C, Pg. 17) that are not consistent with the Baseline allowances adopted for the other residential schedules. Upon review of the record we find no party proposed this treatment

for Baseline allowances. All parties of record as shown in Appendix A of D.84-07-150 have been contacted and no party opposes uniform Baseline allowances for all residential schedules.

Therefore, IT IS ORDERED that D.84-07-150 is modified as follows:

The Baseline allowances for Schedule No. DM-9 shown on page 17 of Appendix C are changed to:
