In the Matter of the Application of William Carroll, dba Airport Stage Lines, for the authority to offer route-deviation pickup and discharge of passengers within a narrow corridor paralleling existing authorized routes to provide improved public service.

Application 84-06-027 (Filed June 6, 1984)

## OPINION

William Carroll, doing business as Airport Stage Lines, holds passenger stage authority (PSC 1135) to operate regular route passenger stage service between points in San Diego, Orange, and Los Angeles Counties.

By this application Carroll requests authority to perform on-call pickup and delivery of passengers within three air miles laterally of either side of his existing routes 1, 2, and 3. These six-mile corridors are described in the application as follows:

"Route 1: The corridor will extend north on either side of Interstate Highway 15 (I-15) beginning at and including the authorized flag stop at Miramar N.A.S.; to the intersection of I-15 and Highway 78; thence west on Highway 78 to the end of the off-ramp for Rancho Santa Fe Road in the City of San Marcos.

"Route 2: The corridor will extend north on either side of Interstate Highway 5 (I-5) beginning at, and including, the authorized flag stop at the Southeast corner of the intersection of Villa La Jolla Drive and La Jolla Village Road, in the community of La Jolla; thence north on either side of I-5 and El Camino Real, following authorized Route 2 to the intersection of El Camino Real and Highway 78; thence east on Highway 78 to the off-ramp for Rancho Santa Fe Road in the City of San Marcos.

"Route 3: The corridor will extend east, on either side, along East Vista Way in the City of Vista; thence north along Mission Road through the community of Bonsal to the Airport Stage station in the community of Fallbrook at the southeast corner of Mission Road and Pepper Tree Lane."

Carroll asserts that to maintain cost effective minimum running time schedules, requests for this service will be computer scheduled to provide the most rapid possible transit for all passengers. He intends to assess a charge of five dollars for each pickup or delivery. He will perform the proposed service with the same equipment presently operated: one 11-passenger Ford bus; one 14-passenger Dodge bus; one 4-passenger Ford station wagon; and one 5-passenger Cadillac limousine.

Notice of filing of the application appeared in the Commission's Daily Transportation Calendar of June 14. No protest has been received.

#### Findings of Fact

- 1. Carroll presently operates a passenger stage service between points in San Diego, Orange, and Los Angeles Counties.
- 2. Public convenience and necessity require the additional service proposed by Carroll in this application.
- 3. The charge to be assessed for the proposed new service is reasonable.

### Conclusion of Law

The application should be granted. Since there is a present need for the proposed service, this decision should be effective today.

# ORDER

#### IT IS ORDERED that:

1. A certificate of public convenience and necessity is granted to William Carroll, authorizing him to operate as a passenger stage corporation, as defined in PU Code § 226, between the points and over the routes set forth in Appendix PSC-1135, to transport persons, baggage, and express.

- 2. The certificate of public convenience and necessity granted in paragraph 1 shall supersede those granted by Decision (D.) 92290, D.82-06-100, and D.84-02-028. Those certificates are revoked on the effective date of the tariff filings required by paragraph 3.b.
  - 3. Applicant shall:
    - a. File a written acceptance of this certificate within 30 days after this order is effective.
    - b. Establish the authorized service and file tariffs and timetables within 120 days after this order is effective.
    - c. State in his tariffs and timetables when service will start; allow at least 10 days' notice to the Commission; and make timetables and tariffs effective 10 or more days after this order is effective.
    - d. Comply with General Orders Series 79, 98, 101, and 104, and the California Highway Patrol safety rules.
    - e. Maintain accounting records in conformity with the Uniform System of Accounts.
    - f. Remit to the Commission the Transportation Reimbursement Fee required by PU Code § 403 when notified by mail to do so.

- 4. Prior to initiating service to any airport, applicant shall notify the airport authority involved. This certificate does not authorize the holder to conduct any operations on the property of or into any airport unless such operation is authorized by both this Commission and the airport authority involved.
- 5. Applicant is authorized to begin operations on the date that the Executive Director mails a notice to applicant that it has evidence of insurance on file with the Commission and that the California Highway Patrol has approved the use of applicant's vehicles for service.
  - 6. The application is granted as set forth above.

    This order is effective today.

SECTION 1. GENERAL AUTHORIZATIONS, RESTRICTIONS, LIMITATIONS, AND SPECIFICATIONS.

William Carroll, an individual, by the certificate of public convenience and necessity granted by the decision noted in the margin, is authorized to operate as a passenger stage corporation to transport passengers and their baggage and express between San Diego International Airport-Lindbergh Field (SAN), in San Diego, on the one hand, and various points and along corridors in Northern San Diego County, including the communities of Escondido, Vista, Fallbrook, San Marcos, Penasquitos, Poway, Carlsbad, and Encinitas, on the other hand, as set forth in the route descriptions below. Also authorized is operation to transport passengers and their baggage and express between the Cities of Escondido, San Marcos, Vista, Carlsbad, Oceanside, and Camp Pendleton, on the one hand, and John Wayne Airport (SNA), Los Angeles International Airport (LAX), Long Beach Municipal Airport (LGB), and Los Angeles and Long Beach Harbors, on the other hand. The authority is subject, however, to change or modification by this Commission at any time and is subject to the following provisions:

- a. Where route descriptions are given in one direction they apply to operation in either direction unless otherwise indicated.
- b. Passengers shall be picked up and discharged only at the authorized stops located at the points and places specified in the route descriptions below.

  - e. The transportation of baggage and express shall be incidental to the transportation of passengers, and shall be limited to a weight of 100 pounds per shipment.

Passengers may, at their request (on-call), be picked up or discharged at the intersection of Mission Road and Pepper Tree Lane in the City of Fallbrook.

Passenger may, at their request (one-call), be picked up or discharged at any point within a corridor three miles on either side of the following course:

Route 3 Northern San Diego County to Los Angeles Basin Air-and Sea-ports

With stops in the City of Escondido, 1511 Grand Avenue in the City of San Marcos (Airport Stage Line terminal), the intersection of Santa Fe Avenue and Escondido Avenue in the City of Vista, the Rapid Transit bus stop in the Plaza Camino Real Shopping Center near the intersection of El Camino Real Highway and Marron Road in the City of Carlsbad, the North County Multi-Mode Transit Station at the intersection of Tremont Street and Mission Avenue in the City of Oceanside, and in Camp Pendleton U.S. Marine Corps Base, on the one hand, and SNA. LCB, Long Beach Harbor, Los Angeles Harbor, or LAX, on the other hand, along the most appropriate streets and highways. Which of the various airports and harbors will be stops on a given trip will be determined by prior reservation or passenger request or a combination thereof. However, no passengers or express will be carried in either direction between any of the airports and harbors listed above.
