OPINION

United Pumping Service, a California corporation, requests a dump truck carrier permit to operate statewide. Notice of the filing of the application appeared in the Daily Transportation Calendar of August 13, 1984. No protests have been filed. Discussion

The application is supported by shippers who need transportation in the Counties of Los Angeles, San Diego, San Bernardino, Orange, Riverside, Ventura, and Santa Barbara. Since there is no showing of need for other counties, the operating authority will be issued to cover operations in the specified counties only. Applicant owns nine tractors and numerous other pieces of equipment. It claims a net worth of \$765,000.

Findings of Fact

1. Applicant:

- a. Is a fit and proper corporation to receive a permit to operate as a dump truck carrier.
- b. Has sufficient operating knowledge and financial ability to initiate and continue the proposed operation.

- c. Has demonstrated that the privilege sought:
 - (1) Will not endanger the safety of the public or interfere with the public use of the public highways or impair the condition or maintenance of them, directly or indirectly.
 - (2) Will not unnecessarily burden the public highways.
 - (3) Is necessary to serve the public and will not impair the ability of presently permitted dump truck carriers to provide adequate service at the lowest possible reasonable rates.
- 2. It can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment.
- 3. The following order complies with the Commission's Energy Efficiency Plan.
- 4. A public hearing is not necessary. Conclusions of Law
- 1. Applicant should be granted a dump truck carrier permit authorizing operations within and between points in the Counties of Los Angeles, San Diego, San Bernardino, Orange, Riverside, Ventura, and Santa Barbara.
- 2. The following order should be effective today to be consistent with other permit grants.

ORDER

IT IS ORDERED that the Executive Director shall issue a dump truck carrier permit to United Pumping Service, a California corporation, authorizing operations within and between points in the Counties of Los Angeles, San Diego, San Bernardino, Orange, Riverside, Ventura, and Santa Barbara upon compliance with General Order Series 100.

This order is effective today.
