<u>o p i n i o n</u>

Eric and Kelly Onnen (applicants), dba Santa Barbara Airbus, hold a passenger stage certificate (PSC-1262) authorizing them to provide ground transportation from Santa Barbara area to Los Angeles International Airport. This application will extend their authority to transport passengers between Santa Barbara Airport, on the one hand, and Santa Barbara/Goleta and Buellton/Solvang on the other. The Buellton/Solvang service will operate only when there is a reservation by at least one passenger.

Applicants also seek to modify the certificate to allow them to change from one terminal location to another in a served city without amending the certificate for each change.

Applicants contend that there is no other carrier which competes with the proposed service. Notice of the application appeared in the Commission's Daily Transportation Calendar on August 8, 1984. No protests were received.

Findings of Fact

1. Public convenience and necessity require the institution of the proposed additional service and certificate modification. 2. The proposed new service will not compete with any existing certificate holder.

Conclusion of Law

Applicant's request to extend its authority to include service between Santa Barbara Airport and Santa Barbara/Goleta and Buellton/Solvang is granted. The request by applicant to modify its certificate to allow it to change terminal locations without amending its certificate is denied for failure to show a compelling need for such precedent creating exception. The Commission has a Route Revision Docket process for making minor modifications to a certificate, which will accomplish the same result that applicants request.

Only the amount paid to the State for operative rights may be used in rate fixing. The State may grant any number of rights and may cancel or modify the monopoly feature of these rights at any time.

ORDER

IT IS ORDERED that:

- 1. PSC-1262 is amended by replacing First Revised Page 1 with Second Revised Page 1, First Revised Page 2 with Second Revised Page 2, and by adding Original Page 4. (Attached.)
 - 2. Applicants shall:
 - a. File a written acceptance of the amended certificate within 30 days after this order is effective.
 - b. Establish the additional authorized service and file tariffs and timetables within 120 days after this order is effective.
 - c. State in their tariffs and timetables when service will start; allow at least 10 days' notice to the Commission; and make timetables and tariffs effective 10 or more days after this order is effective.

- d. Comply with General Orders Series 79, 98, 101, and 104, and the California Highway Patrol safety rules.
- e. Maintain accounting records in conformity with the Uniform System of Accounts.
- f. Remit to the Commission the Transportation Reimbursement Fee required by PU Code § 403 when notified by mail to do so.
- 3. Prior to initiating service to any airport, applicant shall notify the airport authority involved. This certificate does not authorize the holder to conduct any operations on the property of or into any airport unless such operation is authorized by both this Commission and the airport authority involved.
 - 4. The application is granted as set forth above.

SECTION 1. GENERAL AUTHORIZATIONS, RESTRICTIONS, LIMITATIONS, AND SPECIFICATIONS.

Eric Onnen and Kelly Onnen, by the certificate of public convenience and necessity granted by the decision noted in the margin, are authorized to transport passengers and their baggage, between *points in Santa Barbara, Ventura, and Los Angeles Counties as set forth in Section 2, over and along the routes described, subject, however, to the authority of this Commission to change or modify the routes at any time and subject to the following provisions:

- a. Motor vehicles may be turned at termini and intermediate points, in either direction, at intersections of streets or by operating around a block contiguous to such intersections, in accordance with local traffic regulations.
- b. When route descriptions are given in one direction, they apply to operation in either direction unless otherwise indicated.
- c. Only passengers originating at or destined to LAX shall be transported *along Route 1.
- *d. Only passengers originating at or destined to Santa Barbara Airport shall be transported *along Route 2.
