BEFORE THE PUBLIC UTILITIES COMMISSION OF THE STATE OF CALIFORNIA

In the Matter of the Application of RUSSELL BEAUCHANE, doing business as AIRPORT TRANSPORTATION SERVICES, for a certificate of public convenience and necessity to operate a passenger stage corporation, express baggage service, and to transport unaccompanied baggage or any express matters weighing less than 100 pounds per shipment, between the City of Davis and the City of Woodland, on the one hand, and the Sacramento Metropolitan Airport, in the County of Sacramento, on the other hand.

OPINION

Applicant is Russell Beauchane, an individual doing business as Airport Transportation Services. He currently operates as a charter-party carrier under Permit No. 891-P and as a passenger stage corporation between Chico, Paradise, Oroville, Marysville, Yuba City, and Nicholas, on the one hand, and the Sacramento Metropolitan Airport, on the other hand, under authority of PSC-1036 granted by Decision 88745 dated April 18, 1978. Service is provided seven days a week on a scheduled basis.

Applicant has filed to extend service from a Davis
Service Area and a Woodland Service Area to the Sacramento
Metropolitan Airport. Said service areas will extend a radius of
four miles from a specific downtown location in each municipality.
Applicant will charge \$15.00 for round-trip transportation (\$10.00
one-way) between Davis and the airport and \$10.00 round trip (\$7.50
one-way) on the Woodland-Sacramento Airport route. Applicant will

also be transporting unaccompanied baggage or express weighing less than 100 pounds. One fare will be charged for each delivery of express, regardless of the number of bags transported.

Applicant operates out of a terminal in Chico (Butte County) with a 15-passenger bus, 5-10 passenger vans, and 7- and 6-passenger wagons. The capacities listed do not include the drivers. Applicant's last balance sheet for the year ending in December is attached to the application. It shows operating revenue of \$180,534 and operating expenses of \$177,826, with a profit of \$2,708.

It is alleged that Davis (population 40,500) and Woodland (population 33,150) have no scheduled passenger service to the airport. Charter carriers provide service if reservations are made and accepted well in advance of the proposed transportation. It is further alleged that a reliable scheduled passenger service will reduce traffic and congestion on all access roads and in the parking lots at the Sacramento Airport. Lost and misplaced baggage will also be delivered to owners after applicant is authorized to pick it up at the various airlines.

Ambassador Limousine of Davis, California filed a protest late on August 3, 1987. Protestant is not a passenger stage corporation and will not be furnishing the same type of service if the application is granted. The protest will, therefore, be rejected, although protestant does serve the area as a charterparty carrier.

Copies of the application were mailed to six cities and counties and to Ambassador Limousine. The latter protested as previously noted. The filing of this application was noted in the Commission's Daily Transportation Calendar on June 26, 1987. There have been no other protests or requests for hearing.

Pindings of Fact

- 1. Applicant provides a passenger stage service from Chico, Paradise, Oroville, Marysville, Yuba City, and Nicholas, on the one hand, to the Sacramento Metropolitan Airport, on the other hand.
- 2. Applicant has applied to extend service from the airport to a Davis Service Area and a Woodland Service Area.
- 3. Public convenience and necessity require that the proposed service be established.
- 4. The proposed service is not being provided by anyone else.
- 5. A protest filed by a charter operator was rejected, since a grant of the application should not affect the business of a charter-party carrier.
- 6. Applicant has the ability, experience, equipment, and financial responsibility to perform this service.
- 7. It can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment.
- 8. Applicant's authority will be extended as requested by amending applicant's current certificate.

Conclusion of Law

The application should be granted.

Only the amount paid to the State for operative rights may be used in rate fixing. The State may grant any number of rights and may cancel or modify the monopoly feature of these rights at any time.

ORDER

IT IS ORDERED that:

1. A certificate of public convenience and necessity is granted to Russell Beauchane, authorizing him to operate as a passenger stage corporation, as defined in PU Code § 226, between

the points and over the routes set forth in Appendix PSC-1036, to transport persons, their baggage, and/or express.

- 2. Applicant shall:
 - a. File a written acceptance of this certificate within 30 days after this order is effective.
 - b. Establish the authorized service and file tariffs and timetables within 120 days after this order is effective.
 - c. State in his tariffs and timetables when service will start; allow at least 10 days' notice to the Commission; and make timetables and tariffs effective 10 or more days after this order is effective.
 - d. Comply with General Orders Series 79, 98, 101, and 104, and the California Highway Patrol safety rules.
 - e. Maintain accounting records in conformity with the Uniform System of Accounts.
 - f. Remit to the Commission the Transportation Reimbursement Fee required by PU Code § 403 when notified by mail to do so.

3. Prior to initiating service to any airport, applicant shall notify the airport authority involved. This certificate does not authorize the holder to conduct any operations on the property of or into any airport unless such operation is authorized by both this Commission and the airport authority involved.

This order becomes effective 30 days from today.

SECTION 1. GENERAL AUTHORIZATIONS, RESTRICTIONS, LIMITATIONS AND SPECIFICATIONS.

Russell Beauchane, by the certificate of public convenience and necessity granted by the decision noted in the margin, is authorized to transport passengers, baggage and express between Sacramento Metropolitan Airport (SMF) on the one hand; and certain points and areas (described in Sections 2 and 3) on the other hand, over the routes hereinafter described, subject, however, to the authority of this Commission to change or modify the routes at any time and subject to the following provisions:

- (a) Motor vehicles may be turned at termini and intermediate points, in either direction, at intersections of streets or by operating around a block contiguous to such intersections, in accordance with local traffic regulations.
- (b) When route descriptions are given in one direction, they apply to operation in either direction, unless otherwise indicated.
- (c) The transportation of express shall be on passenger-carrying vehicles and shall be incidental to the transportation of passengers and limited to weight of not more than one hundred (100) pounds per shipment.
- (d) Service on Route 1.1 through 6.1 inclusive shall be on a scheduled basis. These routes groups may be combined to make a through trip. Stops may be made along these routes to pick up or discharge passengers, baggage or express. The timetables shall show the location of each service point, and the time-of-day it is served. The tariff shall show the fares for each service.

SECTION 1. GENERAL AUTHORIZATIONS, RESTRICTIONS, LIMITATIONS AND SPECIFICATIONS. (Continued)

- (e) Service on routes 6.2, 7.1 and 7.2 shall be on "on-call" basis. The term "on-call" as used herein refers to service which is authorized to be rendered dependent on the demands of passengers. The tariffs and timetables shall show the conditions under which each authorized on-call service will be rendered.
- (f) "On-call" service shall be limited to the transportation of passengers who originate at or are destined to the service areas described in Section 3.
- (g) This certificate does not authorize the holder to conduct any operations on the property of or into any airport unless such operation is authorized by both this Commission and the airport authority involved.
- (h) Service shall be rendered via a direct route from the point of origin to the point of destination of a passenger, except that when more than one passenger is to be transported in a single vehicle, service shall be rendered by the most direct routings possible, taking into consideration the various points of origin or destination of the several passengers.
