ORDER CORRECTING DECISION 87-10-037

Inadvertently, in Decision (D.) 87-10-037, the Commission did not assign a user fee number applicable to Sacramento Cellular Telephone Company's (applicant) operations as a cellular mobile telecommunications system operator. This decision corrects that omission by assigning user fee number U-3013-C for those operations. Applicant should refile<sup>1</sup> its tariffs using U-3013-C in its Advice Letter No. 1. The user fees applicable to applicant's cellular system operations commence with the onset of such service.

Finding of Fact

D.87-10-037 did not assign a user fee number to reflect applicant's status as a cellular system operator.

Conclusions of Law

1. All user fees applicable to applicant's cellular system operations should be filed under user fee number U-3013-C.

2. Within 10 days after the effective date of this order, applicant should refile its tariffs to reflect its cellular system operator status using user number U-3013-C in Advice Letter No. 1. The filing should be made effective on the date of filing.

IT IS ORDERED that:

1. Sacramento Cellular Telephone Company (applicant) shall remit user fees applicable to its cellular mobile telecommunications operations under user number U-3013-C.

2. Within 10 days after the effective date of this order, applicant shall refile its tariffs to reflect its cellular system operator status using user number U-3013-C in Advice Letter No. 1. The filing shall be effective on the date of filing.

3. D.87-10-037 is corrected as set forth above.

This order is effective today.
