## ORDER DISMISSING APPLICATION

Applicant Lorrie's Travel & Tours, Inc. seeks authority, pursuant to Public Utilities (PU) Code § 4542 to establish a zone of rate freedom between points in its San Francisco Service territories and the San Francisco International Airport. The application was protested by Bay Area SuperShuttle, Inc.

The Commission's Transportation staff filed a motion on January 7, 1988 to dismiss the application. The motion shows that on April 28, 1987 the staff wrote to the applicant, requesting additional information and clarifications. In his July 28, 1987 letter, the applicant's attorney stated that the sought information would be supplied by August 14, 1987. When no information was received, the staff tried to contact the attorney by phone on September 28 without success. On October 2, the staff called the president of applicant and explained the necessity of supplying the sought information immediately. In spite of the staff's best efforts, the applicant has not pursued this application diligently. For lack of response from the applicant, the staff recommends that Application 86-11-045 be dismissed.

Neither applicant nor its attorney has responded to the staff's motion.

On March 1, 1988 the assigned Administrative Law Judge sent a letter to applicant's attorney and to applicant which referred to the herein application and stated as follows:

"On motion filed January 7, 1988 the Commission staff moved to dismiss the above application. To date there has been no response by you to that motion.

"In the event no response to that motion is filed by March 20, 1988 I will recommend to the Commission that the staff's motion be granted and the application be dismissed."

There has been no response to either the subject motion or the letter from the Administrative Law Judge, therefore,
