ORDER EXTENDING STAY OF DECISION 87-12-071

SOUTHERN CALIFORNIA GAS COMPANY (SoCal) has filed an application for rehearing of Decision (D.) 87-12-071, and SAN DIEGO GAS AND ELECTRIC COMPANY (SDG&E) has filed a response in support of that application. Because SoCal's application was filed ten days or more before the effective date of D.87-12-071, the ordering paragraphs of that decision were suspended under § 1733 of the Public Utilities Code. Because we considered the issue presented to be an important one, and needed additional time to consider the matter, we extended the stay on March 9 in D.88-03-040. We have not yet resolved our questions concerning this issue. However, our March 9 stay is due to expire on May 9, two days prior to our next meeting. We consider that fundamental fairness to SoCal requires that the suspension of D.87-12-071 be extended once more.

Therefore,

IT IS ORDERED that: The suspension of Ordering Paragraphs 1 and 2 of D.87-12-071 is hereby extended for sixty days after the effective date of this order, or until we have

issued an order granting or denying the application for rehearing, whichever comes first.

This order is effective today.
