BEFORE THE PUBLIC UTILITIES COMMISSION OF THE STATE OF CALIFORNIA

In the Matter of the Application of San Ramon Valley Airporter Express, Inc., a California corporation, for transfer of the rights under that certain certificate of public convenience and necessity, PSC 1362, from John Berube, dba Airporter Express, to said corporation, and for authority to increase its fares.

# <u>OPINION</u>

John Berube, doing business as Airporter Express, PSC-1362, serves San Francisco and Oakland Airports to and from the San Ramon Valley. He wishes to incorporate and raise fares. He will own 75% of the corporate stock in San Ramon Valley Airporter Express, Inc. The remainder is to be owned by James Karafa. The service is conducted using four vehicles.

He also seeks a fare increase. He has not had a fare increase since 1984. The increases will realize \$40,800 per year (30%) for the San Francisco operation and \$21,000 (50%) for Oakland.

The application shows an operating loss on existing rates of just under \$1,000 on a gross of roughly \$200,000. The following table compares present and proposed fares:

# Findings of Fact

1. The proposed rate increase is justified by the costs of operation.

2. John Berube should be authorized to transfer the certificate and operating property to San Ramon Valley Airporter, Express, Inc.

3. The Commission has received no requests for notification under PU Code § 730.3.

# Conclusions of Law

1. The proposed increase in rates should be granted.

2. The proposed transfer is in the public interest and should be authorized. A public hearing is not necessary.

Only the amount paid to the State for operative rights may be used in rate fixing. The State may grant any number of rights and may cancel or modify the monopoly feature of these rights at any time.

#### ORDER

#### IT IS ORDERED that:

1. By December 1, 1988, John Berube may sell and transfer the operative rights (and property) specified in the application to San Ramon Valley Airporter Express, Inc.

- 2. Purchaser shall:
  - a. File with the Transportation Division written acceptance of the certificate and a copy of the bill of sale or other transfer document within 30 days after transfer.
  - b. Amend or reissue seller's tariffs and timetables, state in them when the service will start, make them effective 10 days or more days after this order is effective, and allow at least 10 days' notice to the Commission.
  - c. Comply with General Orders Series 79, 98, 101, and 104, and the California Highway Patrol safety rules.
  - d. Maintain accounting records in conformity with the Uniform System of Accounts.
  - e. Remit to the Commission the Transportation Reimbursement Fee required by PU Code § 403 when notified by mail to do so.

3. If the transfer is completed, on the effective date of the tariffs a certificate of public convenience and necessity is granted to San Ramon Valley Airporter Express, Inc., a corporation, authorizing it to operate as a passenger stage corporation, as defined in PU Code § 226, between the points and over the routes set forth in Appendix PSC-1362, to transport persons and baggage.

SECTION 1. GENERAL AUTHORIZATIONS, RESTRICTIONS, LIMITATIONS, AND SPECIFICATIONS.

San Ramon Valley Airporter Express, Inc. by the certificate of public convenience and necessity granted by the decision noted in the margin, is authorized to transport passenger and baggage between certain points described in Section 3 on the one hand, and San Francisco International Airport (SFO) and Oakland International Airport (OAK), on the other hand, over and along the routes described, subject, however, to the authority of this Commission to change or modify the routes at any time and subject to the following provisions:

- a. Motor vehicles may be turned at termini and intermediate points, in either direction, at intersections of streets or by operating around the block contiguous to such intersections in accordance with local traffic regulations.
- b. When route descriptions are given in one direction, they apply to operation in either direction unless otherwise indicated.
- c. Service shall be rendered on a regularly scheduled basis.
- d. No passengers shall be transported except those having point of origin or destination at SFO or OAK.
- e. This certificate does not authorize the holder to conduct any operations on the property of or into any airport unless such operation is authorized by both this Commission and the airport authority involved.
