OPINION

Magdy Mikhail Awad, doing business as Mike's Airport Shuttle, holds a passenger stage certificate (PSC-1389) for Los Angeles Airport (LAX) transportation to and from points in Los Angeles and Glendale issued in Decision 85-07-074. Awad seeks authority to transfer PSC-1389 to Mike's Airport Shuttle, Inc., which also holds charter authority (TCP-4295P).

The application is signed by Awad's wife under a general power of attorney granted to her and by a Mr. Husseid as president of the corporation.

Awad alleges that the corporation has the financial capability, the equipment, and the expertise needed to conduct the transportation operation. The transfer will not affect the area served or other aspects of the operation.

Notice of the application appeared in the Commission's Daily Transportation Calendar on July 5, 1988. No protests have been received. On August 9, 1988, the Commission staff recommended that the application be granted.

Findings of Fact

1. No protests have been received and no hearing is required.

2. Mike's Airport Shuttle, Inc. is a fit and proper corporation to hold a passenger stage certificate.

3. Operations will not be affected by this proposed transfer.

Conclusion of Law

The proposed transfer is in the public interest and should be authorized. A public hearing is not necessary.

Only the amount paid to the State for operative rights may be used in rate fixing. The State may grant any number of rights and may cancel or modify the monopoly feature of these rights at any time.

ORDER

IT IS ORDERED that:

1. By June 30, 1989, Magdy Mikhail Awad may sell and transfer the operative rights specified in the application to Mike's Airport Shuttle, Inc.

2. Purchaser shall:

- a. File with the Transportation Division written acceptance of the certificate and a copy of the bill of sale or other transfer document within 30 days after transfer.
- b. Amend or reissue seller's tariffs and timetables, state in them when the service will start, make them effective 10 days or more days after this order is effective, and allow at least 10 days' notice to the Commission.
- c. Comply with General Orders Series 79, 98, 101, and 104, and the California Highway Patrol safety rules.
- d. Remit to the Commission the Transportation Reimbursement Fee required by PU Code § 403 when notified by mail to do so.

3. If the transfer is completed, on the effective date of the tariffs a certificate of public convenience and necessity is granted to Mike's Airport Shuttle, Inc., a corporation, authorizing it to operate as a passenger stage corporation, as defined in PU Code § 226, between the points and over the routes set forth in Appendix PSC-4295, to transport persons and baggage.

4. The certificate of public convenience and necessity granted by Decision 85-07-074 is revoked on the effective date of the tariffs.

This order becomes effective 30 days from today.

SECTION 1. GENERAL AUTHORIZATIONS, RESTRICTIONS, LIMITATIONS,
AND SPECIFICATIONS.

This certificate supersedes all operative authority previously granted to Magdy M. Awad.

Mike's Airport Shuttle, Inc., by the certificate of public convenience and necessity granted by the decision noted in the margin, is authorized as a passenger stage corporation to transport passengers and their baggage between certain points in Los Angeles County and Los Angeles International Airport (LAX), over and along the routes described, subject, however, to the authority this Commission to change or modify this authority at any time and subject to the following provisions:

- a. Motor vehicles may be turned at termini and intermediate points, in either direction, at intersections of streets or by operating around a block contiguous to such intersections, in accordance with local traffic regulations.
- b. When route descriptions are given in one direction, they apply to operation in either direction unless otherwise indicated.
- c. No passengers shall be transported except those having point of origin or destination at LAX.
- d. This certificate does not authorize the holder to conduct any operations on the property of or into any airport unless such operation is authorized by both this Commission and the airport authority involved.
