ORDER DENYING PETITION FOR MODIFICATION

On August 4, 1986, complainants petitioned for modification of Decision (D.) 85-07-090, which ordered a refund to ratepayers for billing overcharges, to request that defendant pay interest on the amounts subject to refund. In D.87-07-012 we ordered interest to be paid on the refund, but failed to refer to the petition for modification, which remains open on our docket. Because the request in the petition was acted upon in D.87-07-012 and in order to clear our docket the petition should be denied.

IT IS ORDERED that the Petition for Modification of D.85-07-090 is denied.
