#### ORDER MODIFYING DECISION 89-01-036

By Decision (D.) 89-01-036, dated January 27, 1989 in Application (A.) 88-10-045, the San Diego Unified Port District (SDUPD) and the San Diego Metropolitan Transit Development Board (MTDB) were authorized to perform the following items: 1) partially relocate Market Street; 2) close India Street across the tracks of The Atchison, Topeka and Santa Fe Railway Company (AT&SF) main line; 3) remove one freight track; and 4) add two light rail vehicle (LRV) tracks for exclusive use of the LRT system, in San Diego, San Diego County.

AT&SF, by letter dated February 23, 1989, advised the Commission staff that in the railroad's opinion, an ordering paragraph should be added to D.89-10-045 to provide full traffic signal preemption at the intersection of Market Street and Harbor Drive.

The Safety Division Traffic Engineering staff, after an on-site field review and discussion with all concerned parties, is of the opinion the following ordering paragraph should be inserted to Page 5 of D.89-10-045:

"6a. Traffic signals at the intersection of Market Street and Harbor Drive shall be preempted by train and LRV movements."

This would be in accordance with traffic signal preemption which is required by General Order (GO) 75-C, through its reference in Section 7.10 to the "Manual of Uniform Traffic Control Devices" published by the Federal Highway Administration.

Ordering paragraph 1 on Page 5 should also be changed to show the MTDB crossing number as 81 - 0.5 at the joint crossing. It was incorrectly identified as 82 - 0.5.
