ORDER GRANTING STAY OF RESOLUTION TS-684

An Application for Rehearing of Resolution TS-684 was filed by California Trucking Association (CTA). This Application for Rehearing requested that the Commission issue an immediate stay of the rate decreases ordered by Resolution TS-684. On October 12, 1989 the Commission granted CTA's request by issuing a stay of the rate decreases ordered by Resolution TS-684 in Decision 89-10-036. Additionally on October 12, 1989 the Commission issued Decision 89-10-039, effective in 30 days, the Decision on Rate Safety and Subhaul Regulations for General Freight Transportation, preempting Resolution TS-684. Unless we take action today to grant an immediate stay of the rate increases ordered in Resolution TS-684, these rate increases will go into effect before Decision 89-10-039 is effective. Such a result will cause confusion to the businesses governed by Resolution TS-684 and Decision 89-10-039. Therefore, we will grant an immediate stay of all portions of Resolution TS-684. Carriers who have already complied with Resolution TS-684 may on not less than 5 days notice rescind the rate changes made pursuant to that Resolution.

IT IS ORDERED that:

Resolution TS-684 is stayed until further order of the Commission.


Carriers who have already complied with Resolution TS-684 may on not less than 5 days notice rescind the rate changes made pursuant to that Resolution.
