ORDER EXTENDING TIME

By Ordering Paragraph One of Decision (D.) 86-06-056 dated June 25, 1986, Southern California Edison Company (Edison) was authorized to issue up to \$300,000,000 of Debt Securities; to guarantee the obligations of others in respect of the issuance of securities; to execute and deliver one or more indentures; to sell, lease, assign, mortgage or otherwise dispose of or encumber utility property and to be exempt from the Commission's Competitive Bidding Rule for the issuance and sale of its Debt Securities on or prior to May 31, 1988. By D.88-05-008, the authority granted in D.86-06-056 was extended to May 31, 1990.

By Petition for Modification of Decision 86-06-056, filed June 6, 1990, and appearing on the Commission's Daily Calendar on June 13, 1990, Edison requests an extension of time until June 30, 1992. No protests have been received to date, and with good cause appearing,

IT IS ORDERED that:

1. Southern California Edison Company may issue and sell its Debt Securities in an aggregate principal amount up to

\$300,000,000 for the purposes stated in the application and as authorized by Decision 86-06-056 dated June 25, 1986 in the above entitled matter. This authority is hereby extended to May 31, 1992.


2. This extension of time is granted as set forth above.
