## ORDER CORRECTING CLERICAL ERROR

It has come to our attention that Surcharge Supplement 30 to Minimum Rate Tariff 7-A accompanying Decision 90-08-033 does not reflect the Commission's intent to bring forward exceptions from previous Supplement 29.

In order to correct this error, the decision should be amended as set forth in the ensuing order.

Pursuant to Resolution A-4661, IT IS ORDERED that:

- 1. Minimum Rate Tariff 7-A (Appendix B to Decision 82061, as amended) is further amended by incorporating Supplement 31, attached, to become effective September 7, 1990.
- 2. In all other respects, Decision 90-08-033, as amended, shall remain in full force and effect.

3. The Executive Director shall serve a copy of this decision on each subscriber to Minimum Rate Tariff 7-A.

## (E) APPLICATION OF SURCHARGE

Except as otherwise provided, compute the amount of charges in accordance with the rates and rules of this tariff, and increase the amount so computed as follows: (SEE EXCEPTION)

- By one and three-tenths (1.3) percent on hourly, distance and zone rates except as provided by paragraph 2 below.
- By eight-tenths (0.8) percent for the transportation of commodities described in Item 30, List B, and petroleum coke as described in Item 60 and Item 325, and commodities in permanent enclosed hoppers.

For purposés of disposing of fractions under provisions hereof, fractions of less than one-half (1/2) cent shall be dropped and fractions of one-half (1/2) cent or greater shall be increased to the next higher whole cent.

EXCEPTION: The surcharge herein shall not apply to:

- 1. Items 100 and 110 (Railhead-tó-railhead charges only);
- 2. Item 120 Bridge and Ferry Tolls; and
- 3. Item 260 Additional charge for service.
