Application of Century Yuma Paging Corp. to purchase all issued and outstanding stock of Hendrix Electronics, Inc. and to acquire control of Hendrix Radio Communications, Inc., dba Cal-Com Radio Telephone Service (U-2005-C) and (U-5137-C) and application for the sale and transfer of property and request for expeditious relief.

ORDER MODIFYING DECISION 90-08-071

The Commission has been informed by letter dated September 5, 1990, that there are certain inadvertent errors in Decision (D.) 90-08-071.

D.90-08-071 mistakenly assumed that Hendrix Electronics, Inc. (Hendrix) would be merged into Century Yuma Paging Corporation (Century Yuma), with Century Yuma as the surviving corporation providing public utility service in California.

However, as noted in the referenced letter, applicant intended only to acquire the stock of Hendrix. Applicant intended that both Hendrix and Hendrix Radio Communications, Inc., dba Cal-Com Radio Telephone Service (Cal-Com) will remain in existence.

The errors are in Ordering Paragraphs 2, 3, 4, 6, and 7 through 10.

We find that the inadvertent errors need to be corrected to reflect the intent of applicant.

Finding of Fact

There are inadvertent errors in D.90-08-071.

Conclusion of Law

D.90-08-071 should be modified to correct the inadvertent errors.



APPENDIX A

ORDER

IT IS ORDERED that:

1. On or after the effective date of this order, Century Yuma Paging Corporation (Century Yuma) may purchase all the stock of Hendrix Electronics, Inc. (Hendrix), thereby acquiring control of Hendrix Radio Communications, Inc. in accordance with the terms described in the application.

2. Century Yuma shall inform the Commission Advisory and Compliance Division Director in writing of the actual date of sale completion and of transfer of central.

3. Within 90 days after sale completion, Hendrix shall file with the Commission, in the prescribed form, an annual report on its operations from the first day of the current year through the date of sale completion.

4. The authority granted to render service under the rates, charges, and rules authorized will expire if not exercised within 12 months after the effective date of this order.
