ORDER ADDING RESPONDENTS

The order instituting this investigation named three respondents: Pacific Gas and Electric Company (PG&E), San Diego Gas & Electric Company (SDG&E), and Southern California Edison Company (SCE). However, the investigation is deliberately broad, and we believe it should include all jurisdictional investor-owned electric utilities with substantial transmission facilities serving the California market. Accordingly, Pacific Power & Light Company (PP&L) and Sierra Pacific Power Company (SPP) should be added as respondents.

Under the current schedule, initial comments in this proceeding are to be filed and served by November 30, 1990, and reply comments are to be filed and served by January 4, 1991. The newly named respondents are already parties to this proceeding; however, we do not know whether they planned to participate actively. In order to ensure that PP&L and SPP have adequate time to respond fully, we will allow them to file and serve their initial comments together with their reply comments on January 4, 1991. Parties wishing to reply to the comments of PP&L and SPP shall file and serve their replies no later than January 18, 1991.

We note that this proceeding involves a long service list and comments that are apt to be voluminous. A modification of normal service procedure is appropriate in order to save time, resources, and money. Accordingly, filers in this proceeding need

automatically serve the full text of their comments (initial or reply) only on those parties that request such service in writing. For all parties not so requesting, filers need only serve notice that the comments (initial or reply) have been filed and that a copy will be supplied upon request.

IT IS ORDERED that:

1. Pacific Power & Light Company (PP&L) and Sierra Pacific Power Company (SPP) are made respondents to this proceeding.
2. PP&L and SPP shall file and serve their initial comments together with their reply comments on January 4, 1991. Parties wishing to reply to the comments of PP&L and SPP shall file and serve their replies no later than January 18, 1991.
3. Parties filing initial and reply comments in this proceeding shall serve the full text of such comments on all parties that so request in writing. Where no such written request has been received from a given party, the filer need only serve a notice on the party stating that the filer has submitted comments and will serve the full text of such comments on request.

This order is effective today.


