Application of Ali H. Sabbah and Nasser H. Sabbah, doing business as Falcon Bus Lines, for certificate of public convenience and necessity to operate as a passenger stage corporation between Fort Bragg, California and San Francisco, California.

<u>OPINION</u>

This decision grants the application of Ali H. Sabbah and Nasser H. Sabbah (applicants), doing business as Falcon Bus Lines, for a certificate of public convenience and necessity. Applicants seek authority to establish and operate a passenger stage corporation to transport passengers, baggage, and express between Fort Bragg and San Francisco.

The application provides a map of the proposed routes, a schedule of proposed fares, a financial statement, and a description of the equipment to be used. The route between Fort Bragg and San Francisco would make stops at Navarro, Boonville, Cloverdale, Santa Rosa, and Ignacio. Fares would be charged according to distance at a rate of \$.18 per mile for one-way trips and a rate of \$.16 per mile for round trips. The service would be offered seven days a week, and is designed to permit passengers to travel from Fort Bragg to Santa Rosa or San Francisco and return on the same day. Applicants state a wheelchair lift may be installed on their vehicles if there is a need for it. Applicants' financial statement shows annual net revenue of \$19,748 or \$23,624, depending on the assumptions applied. Applicants show net assets of \$44,025. An attachment to the application states that one of the applicants has over 12 years of experience operating a business, and both have experience driving commercial vehicles.

Applicants state their request for this authority was motivated by their understanding that Greyhound Bus Lines (Greyhound) seeks to abandon the route which is the subject of this application. Applicants believe Greyhound's proposed abandonment presents applicants a business opportunity which will benefit the Fort Bragg community.

We agree with the applicants that a need for their proposed service exists if Greyhound abandons the route between Fort Bragg and San Francisco, as it has proposed in Application (A.) 90-09-061. Transportation Division Staff has reviewed the application and recommends that it be granted. No protest to the application has been filed.

Pindings of Pact

1. Greyhound has filed A.90-09-061 seeking abandonment of its route between Fort Bragg and San Francisco.

2. Applicants seek to continue passenger stage service between Fort Bragg and San Francisco.

3. Applicants have the ability, equipment, and financial resources to perform the proposed service.

4. Public convenience and necessity require the proposed service.

5. The rates proposed in the application are reasonable.

6. It can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment.

7. No protest to the application has been received.

8. As the evidence in this case shows a compelling present need for the proposed service, the order should be effective on the date of signing.

<u>Conclusion of Law</u>

Public convenience and necessity have been demonstrated and a certificate should be granted. Only the amount paid to the State for operative rights may be used in rate fixing. The State may grant any number of rights and may cancel or modify the monopoly feature of these rights at any time.

<u>ORDER</u>

IT IS ORDERED that:

1. A certificate of public convenience and necessity is granted to Ali H. Sabbah and Nasser H. Sabbah (applicants), authorizing them to operate as a passenger stage corporation, as defined in Public Utilities (PU) Code § 226, between the points and over the routes set forth in Appendix PSC-7042 to transport persons and baggage.

- 2. Applicants shall:
 - a. File a written acceptance of this certificate within 30 days after this order is effective.
 - b. Establish the authorized service and file tariffs and timetables within 120 days after this order is effective.
 - c. State in their tariffs and timetables when service will start; allow at least 10 days' notice to the Commission; and make timetables and tariffs effective 10 or more days after this order is effective.
 - d. Comply with General Orders Series 101, 104, and 158, and the California Highway Patrol safety rules.
 - e. Maintain accounting records in conformity with the Uniform System of Accounts.
 - f. Remit to the Commission the Transportation Reimbursement Fee required by PU Code § 403 when notified by mail to do so.

3. Before beginning service to any airport, applicants shall notify the airport's governing body. Applicants shall not operate into or on airport property unless such operations are also authorized by the airport's governing body.

4. Applicants are authorized to begin operations on the date that the Executive Director mails a notice to applicants that their evidence of insurance is on file with the Commission and that the California Highway Patrol has approved the use of applicants' vehicles for service.

The application is granted as set forth above.
This order is effective today.
