SECTION 1. GENERAL AUTHORIZATIONS, RESTRICTIONS, LIMITATIONS, AND SPECIFICATIONS.

Ronald George LaGoe, by the certificate of public convenience and necessity granted by the Decision noted in the margin, is authorized as a passenger stage corporation to provide on-call services to transport passengers and baggage between points in Yolo County, Sacramento County and Sacramento Metropolitan Airport, subject, however, to the authority of this Commission to change or modify this authority at any time and to the following provisions:

- a. When route descriptions are given in one direction, they apply to operation in either direction, unless otherwise indicated.
- b. No service shall be provided to or between intermediate points. Only passengers originating at or destined to Sacramento Metropolitan Airport will be transported.
- c. The term "on-call" as used here refers to service which is authorized to be rendered dependent on the demands of passengers. The tariffs and timetables shall show the conditions under which each authorized on-call service will be rendered.
