> "Peter Lawrence Heine requests to transfer his passenger stage authority, PSC-975, to Earnest Alvin Borchers. Heine will transfer the assets and liabilities connected with the passenger stage business including two fifteen passenger vans. The authority provides daily service between Fort Bragg and Little River Airport and points intermediate thereto, between Fort Bragg and Heritage House, between Little River and Heritage House, and express shipments weighing less than fifty pounds between Fort Bragg, on the one hand, and Mendocino, Little River, Little River Airport, and Heritage House, on the other hand as specified in Decision 91602 in Application 59449, amended by D.87153, A.55954.

> "Staff recommends that in the absence of the second protest, the transfer application be granted by ex parte order."

2. Heine received a certificate of public convenience and necessity (PSC-975) to operate as a passenger stage corporation in Decision (D.) 91602 in Application (A.) 59449, amended by D.87153 in A.55954. He is authorized to operate between certain points in Mendocino County.

3. Borchers currently operates a local delivery business in partnership with Heine, subject to Commission jurisdiction.

4. The property involved in the transfer includes all of the assets and liabilities of Heine utilized or acquired by Heine in connection with his passenger stage corporation business.

5. The transfer shall not affect the territory or points currently served, or the nature of the service, which shall continue as authorized by the Commission.
