ORDER MODIFYING DECISION 91-07-041

By Decision (D.) 91-07-041 in this proceeding, dated July 24, 1991, we authorized Airport Cruiser, Inc. to provide extended service as a passenger stage corporation between points in Orange County, Los Angeles International Airport (LAX), and John Wayne Airport. Through inadvertence, the applicant was authorized to provide service between John Wayne Airport and only two specific hotel destinations in Garden Grove and Orange, and between LAX and five specific hotels or businesses in Newport Beach, Irvine, and Costa Mesa.

Airport Cruiser, Inc. points out that it had requested authority to serve between John Wayne Airport and all points in the cities of Garden Grove and Orange, and between LAX and all points in the cities of Newport Beach, Irvine, and Costa Mesa. In the circumstances, D.91-07-041 should be modified to reflect the applicant's intent. This portion of the applicant's request is uncontested. A public hearing is not necessary.

Findings of Fact

1. D.91-07-041 authorized Airport Cruiser, Inc. to provide extended passenger stage corporation service between John Wayne Airport and specific hotels in the cities of Garden Grove and

Orange, and between LAX and specific hotels and businesses in the cities of Newport Beach, Irvine, and Costa Mesa.

2. Airport Cruiser, Inc. had requested authority to provide service between John Wayne Airport and all points in the cities of Garden Grove and Orange, and between LAX and all points in the cities of Newport Beach, Irvine, and Costa Mesa.

Conclusion of Law

D. 91-07-041 should be modified to reflect the applicant's intent.

IT IS ORDERED that:

1. Appendix PSC-5877 to Decision 91-07-041 in this proceeding, dated July 24, 1991, is modified by substituting Second Revised Page 3, attached, for First Revised Page 3.

2. In all other respects, Decision 91-07-041 shall remain in full force and effect.

This order is effective today.



SCHEDULED SERVICES

Route 1 LAX - Anaheim, Buena Park.

Commencing at LAX then, via the most convenient streets and highways to the scheduled stops in the cities of Anaheim and Buena Park (specified in the tariff and timetables).

*Route 2. SNA - Orange County.

Commencing at SNA then via the most convenient streets and highways to specific scheduled stops in the cities of Garden Grove and Orange.

*Route 3 LAX - Newport Beach, Irvine, Costa Mesa.

Commencing at LAX then, via the most convenient streets and highways to specific scheduled stops in the cities of Newport Beach, Irvine and Costa Mesa.
